A BY-LAW to amend By-law No. 1991 being the "Burnaby Town Planning By-law 1948."

- 1. This By-law may be cited as "BURNABY TOWN PLANNING BY-LAW 1948, AMENDMENT BY-LAW NO. 2, 1959."
- 2. Schedule 3 of By-law No. 1991 is amended by adding thereto the following as clause (53):

Lots 11 to 17 inclusive and 20, Block 62, District Lots 122, 123 and 124, Plan 1543; Lot "A", Block 62, District Lots 122, 123 and 124, Plan 13611; Lots 1 to 10 inclusive, Block 63, District Lots 122, 123 and 124, Plan 1543; Lots 6 to 10 inclusive, Subdivision "A", Block 63, District Lots 122, 123 and 124, Plan 12275; Parcel 1, Subdivision "A", Block 63, District Lots 122, 123 and 124, Explanatory Plan 11478, Plan 4846; Lots 1 to 5 inclusive, Subdivision "A", Block 63, District Lots 122, 123 and 124, Plan 11028; Lots 10 to 18 inclusive, Block 69, District Lots 122, 123 and 124, Plan 1543; Block 70, District Lots 122, 123 and 124, Plan 3684; Blocks 72 and 73, District Lots 122, 123 and 124, Plan 1543; Lot "G" save and except Plans 13744, 14242, and 15025, District Lots 122, 123 and 124, Plan 1543; Lot "G" save and except Plans 13744, 14242, and 15025, District Lots 122, 123 and 124, Plan No. 13725, Group 1, New Westminster District."

3. Clause (d) of section 1 of Schedule 1 of By-law No.
1991 is amended by deleting therefrom the lands more particularly described in section 2 hereof.
