

BY-LAW NO. 4055

A BY-LAW to establish a public highway.

The Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD DEDICATION BY-LAW NO. 3, 1959."
2. The Municipal Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire for highway purposes from the registered owners thereof by a good and sufficient deed in fee simple, in consideration of the sum of one (\$1.00) dollar, those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia and more particularly known and described as all that portion of Lot 35, of Blocks 1 to 5, of Lot 159, Group 1, New Westminster District, Plan 1219, commencing at the north westerly corner of the said Lot 35; thence south easterly along the south west boundary of the said Lot 35 a distance of 233.70 feet more or less to the south easterly corner thereof; thence northerly along the easterly boundary of the said Lot 35 a distance of 25.76 feet; thence north westerly and parallel to the said south westerly boundary of the said Lot 35 a distance of 199.37 feet more or less to the north boundary thereof; thence westerly along the said north boundary a distance of 22.65 feet more or less to the point of commencement; and containing 3681 square feet more or less, as shown outlined in red colour on the plan hereunto annexed prepared by D. J. Roy, B. C. L. S., dated the 16th day of June, 1959.
3. The Municipal Council of The Corporation of the District of Burnaby does hereby establish as public highway

those municipally-owned lands and premises more particularly known and described as that portion of Lot 34 of Blocks 1 to 5 of Lot 159, Group 1, New Westminster District, Plan 1219, commencing at the south westerly corner of the said Lot 34; thence south easterly along the south west boundary of Lot 34 a distance of 114.53 feet more or less to an angle in the said boundary; thence easterly along the southerly boundary of Lot 34 a distance of 25.83 feet more or less to the south east corner thereof; thence northerly along the east boundary of Lot 34 a distance of 1.62 feet; thence north westerly and parallel to the said south westerly boundary of Lot 34 a distance of 151.64 feet more or less to the west boundary thereof; thence south along the said west boundary a distance of 25.76 feet more or less to the point of commencement; and containing 2284 square feet more or less, as shown outlined in red colour on the said plan prepared by D. J. Roy, B. C. L.S., dated the 16th day of June, 1959.

4. Upon registration of the aforesaid deed and upon registration of a certified copy of this by-law in the Land Registry Office in the City of New Westminster in the Province of British Columbia the aforesaid portions of Lots 34 and 35 of Blocks 1 to 5, of Lot 159, Group 1, New Westminster District, Plan 1219, shall be established as a public highway.
