

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4058

A BY-LAW to amend By-law No. 1991 being the
"Burnaby Town Planning By-law 1948."

WHEREAS applications for rezoning have been made
to the Municipal Council.

AND WHEREAS the Municipal Council has held a
public hearing thereon after duly giving notice of the
time and place of such hearing.

NOW THEREFORE the Municipal Council of The
Corporation of the District of Burnaby ENACTS as
follows:

1. This By-law may be cited as "BURNABY TOWN PLANNING
BY-LAW 1948, AMENDMENT BY-LAW NO. 7, 1959."

2. Section (4) of Schedule 1 of By-law No. 1991 is
amended by adding the following thereto as clause (m):

"(m). The westerly 132 feet of Lot "A", except
Explanatory Plan 13518, Block 3, District Lot 122, Group
1, New Westminster District, Plan 1308."

3. Schedule 3 of By-law No. 1991 is amended by
adding thereto the following, as clause (55):

"(55). Lots 12, 13 and 14, Block 4, of the east
half of District Lot 119, Group 1, New Westminster Dis-
trict, Plan 2855."

4. Schedule 5 is amended by adding thereto the
following under the heading Central Area:

(a). "The west 75 feet of the west half of Lot 2,
Block 14, District Lot 70 west half of east 50 acres,
Group 1, New Westminster District, Plan 3824, save and
except the south 20 feet thereof."

(b). "West half of Lot 2, except the west 75 feet, and except Explanatory Plan 13502, Block 14, District Lot 70 west half, of east 50 acres, Group 1, New Westminster District, Plan 3624, save and except the south 20 feet thereof."

5. Schedule 7 is amended by striking out the figures "12, 13, 14" in clause (a) thereof.

6. Schedule 8 is repealed and the following substituted therefor:

"AGRICULTURAL ZONE

(1) All that area bounded by Trapp Road, Willard Avenue, Thorne Avenue, E. C. Electric Margpole right-of-way, Meadow Avenue, 14th Avenue, Marine Drive and Fenwick Avenue, save and except

(a) Lot 18 and south half of Lot 20, both of Block 10, District Lot 173, Group 1, New Westminster District, Map No. 1034.

(b) Lots 1 to 5 inclusive, Subdivision 8, and Lots 1 to 5 inclusive Subdivision 13, all of Block 4, District Lot 173, Group 1, New Westminster District, Plan 9015."
