THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4095

A BY-LAW to acquire certain lands and dedicate the same for highway purposes.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD ACQUISI-TION AND DEDICATION BY-LAW NO. 6, 1959."

2. The Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from the registered owners thereof by a good and sufficient deed in fee simple, free and clear of all encumbrances, for highway purposes, in consideration of the sum of one (\$1.00) dollar, those lands and premises situate, lying and being in the Municipality of Burnaby, Province of British Columbia, and more particularly known and described as that portion of the south 152 feet of Lot 1, of Block 1, District Lot 136, Group 1, New Westminster District, Plan 3053.

Commencing at the southeasterly corner of said south 152 feet of Lot 1;

Thence N 89° 47' 40" W and following the southerly boundary of south 152 feet of Lot 1, aforesaid, 32.49 feet, more or less, to an intersection with the northerly prolongation of the easterly boundary of Lot 4, according to Plan 16984;

Thence N 5° 08' E, 152.87 feet, more or less, to a point on the northerly boundary of said south 152 feet of Lot 1, said point being the southeasterly corner of Lot 8, according to Plan 20816 ,

Thence S 89° 46' 40" E and following the northerly boundary of south 152 feet of Lot 1, aforesaid, 20.0 feet, more or less, to the northeasterly corner thereof; Thence S 0° 26' 50" W and following the easterly boundary of said south 152 feet of Lot 1, 152.30 feet, more or less, to the point of commencement, and containing by admeasurement 0.092 of an acre, be the same more or less, as shown outlined in red on the plan prepared by C. P. Aplin, B. C. L. S., certified on the 20th day of October, 1959, a copy of which is hereunto annexed.


2. Upon registration of the said deed in fee simple in the Land Registry Office in the City of New Westminster, Province of British Columbia, the lands hereinbefore described shall be established as a public highway.
