BY-LAW NO. 4107

A BY-LAW to authorize the expropriation of certain real property for the widening of Tenth Avenue in the Municipality of Burnaby.

WHEREAS it is desirable and in the public interest to widen Tenth Avenue in the Municipality of Burnaby from Fourth Street to Newcombe Street.

AND WHEREAS for such purposes it is necessary to expropriate certain real property abutting upon the said portion of Tenth Avenue.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY TENTH AVENUE WIDENING EXPROPRIATION BY-LAW 1960."

2. The Council of The Corporation of the District of Burnaby, for the purpose of widening Tenth Avenue from Fourth Street to Newcombe Street, is hereby authorized and empowered, without the consent of the owners of the real property but subject to the provisions of Division (4) of Part XII of the Municipal Act:-

(a) by its servants and agents to enter upon, expropriate, break up, take or enter into possession of or use the southeasterly ten feet of those parcels of real property hereinafter described being measured at right angles to the southeasterly boundaries of the same and adjoining Tenth Avenue:

(i) Lots 17 and 18 and Lots 20 to 36 inclusive, Block 1, District Lot 27, Group 1, Plan 697, New Westminster District.

(ii) Lots 12 to 17 inclusive, Block 2,

District Lot 27, Group 1, Plan 697, New Westminster District.

(iii) Lots 1 to 4 inclusive, Block 3, District Lot 27, Group 1, Plan 13975, New Westminster District.

(iv) Westerly 69 feet of Lot 1, Block "A" of Block 2, of Lot 27, Group 1, Plan 5978, having a frontage of 69 feet on Tenth Avenue by full depth of said lot and adjoining Second Street, New Westminster District.

(v) Lots 5 and 6, of Lot 1, Block "A" of Block 2, District Lot 27, Group 1, Plan 14576, New Westminster District.

(vi) East 50 feet of Lot 1, Block "A" of Block 2, District Lot 27, Group 1, Plan 5978, New Westminster District.

(vii) East 48 feet of Lot "B", Block 3, District Lot 27, Group 1, Plan 3997, New Westminster District.

(viii) Lots 15 and 16, of Lot 3, Block 1, District Lot 25, Group 1, Plan 1169, New Westminster District.

(b) by its servants and agents to enter upon any real property which may be injuriously affected by the said widening of Tenth Avenue for the purpose of executing any works of construction, maintenance, or repair in mitigation of injuries done or apprehended or in reduction of compensation.

3. This By-law shall, before coming into effect, be published once in the B. C. Gazette and in a newspaper published or circulating in the Municipality of Burnaby and a certified copy of the by-law shall be filed in the Land Registry Office in the City of New Westminster, in the Province of British Columbia.




