

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4121

VF 1757F

A BY-LAW to amend By-law 1991 being "Burnaby
Town Planning By-law 1948."

WHEREAS applications for rezoning have been made to
the Council.

AND WHEREAS the Council has held a public hearing thereon
after duly giving notice of the time and place of such hearing.

NOW THEREFORE the Council of The Corporation of the
District of Burnaby ENACTS as follows:-

1. This By-law may be cited as "BURNABY TOWN PLANNING BY-
LAW 1948, AMENDMENT BY-LAW NO. 3, 1960."

2. Schedule 3 of "Burnaby Town Planning By-law 1948" is
amended by adding the following thereto as items (57) to (62).

"(57) Lots "A" and "B" of Lot 2, Block 2 of Lot 158,
Group 1, Plan 3423, New Westminster District.

(58) Lot "B" of Lot 3, Block 2 of Lot 158, Plan 3423,
New Westminster District.

(59) Lot "H" of Lots 3 and 4, Block 2 of Lot 158,
Plan 6917, New Westminster District.

(60) Lot "D" of Lot 4, Block 2 of Lot 158, Plan 3423,
New Westminster District.

(61) Lot "D" of Lot 5, Block 2 of Lot 158, Plan 3423,
New Westminster District.

(62) Lot 1 of Lot "C", Blocks 2 and 3 of Lot 2, Plan
10399, save and except the Westerly 160' thereof,
New Westminster District."

3. Schedule 4 is amended by adding the following thereto as
items (34) and (35).

"(34) Lot 1, Block 136 of Lot 92, Plan 3896, New
Westminster District.

(35) Lot 2, Blocks 135 and 136 of Lot 92, Plan 2447,
New Westminster District."

4. Schedule 6 is amended by deleting the following therefrom:

"That portion of Block "E" of Lots 69 and 70,
Group 1, Plan 14996, New Westminster District,
bounded by Carleton Avenue, the proposed 'Carleton
Diversion', and Norfolk Street, as shown on the
sketch attached hereto and forming part of this
by-law."

5. Schedule 11 is amended by adding the following there-
to as items (7) to (13).

- "(7) That portion of Block "E", of Lot 69 and 70, Group 1, Plan 14996, New Westminster District, bounded by the proposed eastward extension of Manor Street immediately South of and abutting the Freeway right of way, Sumner Avenue, Norfolk Street, and the proposed 'Carleton diversion', as shown on the sketch attached hereto.
- (8) East half of Lot 1 of Block 14 of Lot 70, Plan 3824 except the West 75' thereof, New Westminster District.
- (9) West 75' of the West half of Lot 2, Block 14 of Lot 70, Plan 3824, New Westminster District.
- (10) Parcel "B" Reference Plan 16990 of Lot 2, Block 14, of Lot 70, Plan 3824, New Westminster District.
- (11) Parcel "A" Explanatory Plan 13502 of Lot 2, Block 14 of Lot 70, Plan 3824, Except part on Reference Plan 16990, New Westminster District.
- (12) The West Half of Lot 1, Block 14 of Lot 70, Plan 3824, New Westminster District.
- (13) The West 75' of the East Half of Lot 1, Block 14, of Lot 70, Plan 3824, New Westminster District."

6. Schedule 12 is amended by adding the following thereto
as item (8).

- "(8) All that area bounded by the Freeway right of way, Willingdon Avenue, Norfolk Street and Sumner Avenue, as shown on the sketch attached hereto."
