THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4153

A BY-LAW to stop up and close to traffic portions of Russell Avenue and Watling Street.

WHEREAS those portions of Russell Avenue and Watling Street shown outlined in red colour on the plan annexed hereto prepared by M. Bruce Paterson, B.C.L.S, certified on the 8th day of April, 1960, were established by those certain plans deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, as Nos. 824, 1829 and 3993.

AND WHEREAS the said portions of Russell Avenue and Watling Street have not been constructed and are not now required for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. This By-law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 4, 1960".
2. Those portions of Russell Avenue and Watling Street shown outlined in red colour on the said plan hereunto annexed and more particularly described as:

ALL AND SINGULAR that certain tract or parcel of land and premises, situate, lying and being a portion of District Lot 97 Group 1, New Westminster District in the Municipality of Burnaby and being a public road dedicated by the deposit of Plans numbered 824, 1829 and 3993, which parcel may be more particularly described as follows:

"Commencing at the North East corner of Parcel G of District Lot 97, Group 1, New Westminster District as same is shown on Plan 18415 thence N.89°18'10"E 33.00 feet more or less to an intersection with the West boundary of Parcel A, Block 23, Plan 3993; thence S.0°23'30" W and following the Westerly boundary of the said Parcel A, Block 23, 235.28 feet more or less to the South West corner of the said Parcel A; thence N.89°37'20" E and following the Southerly boundary of the said Parcel A 211.83 feet more or less to

the South East corner of Parcel A; thence S.0°09'40" W and following the southerly production of the Easterly boundary of Parcel A, 33.00 feet more or less to its intersection with the North boundary of Lot 6 of District Lot 97 according to Plan number 21397; thence S.89°37'20" W and following the North boundary of the said Lot 6 244.51 feet more or less to the South East corner of Lot 4, Plan number 21397; thence N.0°23'30" E 268.10 feet more or less to the point of commencement, the said parcel containing 0.363 acres and is shown outlined in red on plan attached hereto."

are hereby stopped up and closed to traffic.

3. The Reeve and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon those portions of Russell Avenue and Watling Street more particularly hereinbefore described and vest title thereto in The Corporation of the District of Burnaby.
