BY-LAW NO. 4159

A BY-LAW to stop up and close to traffic a portion of Napier Street.

WHEREAS that portion of Napier Street shown outlined in Red colour on the plan annexed hereto prepared by J. E. Herman, B.C.L.S, and dated June 17th, 1960, was established as a highway by that certain plan deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, as Number 2639.

AND WHEREAS the said portion of Napier Street has not been constructed and is not now required for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 5, 1960".

2. That portion of Napier Street more particularly described as :

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Province of British Columbia, in the District of New Westminster, in the Municipality of Burnaby, and being composed of a Portion of Lot 129, Plan 2639, and which said Portion may be more particularly known and described as follows, that is to say:-

"Commencing at the north easterly corner of Lot "A" of Lot 28 of Lot 129, Plan 21474. Thence North and following the westerly boundary of Fell Avenue a distance of 66 feet, more or less, to the south easterly corner of Lot 9 of Lot 129, Plan 2639. Thence S.89°49' W. and following the southerly boundary of Lot 9 aforesaid, a distance of 122.13 feet, more or less, to a point, said point being distant 10 feet easterly from the south westerly corner of said Lot 9. Thence S.0°00'30" E. a distance of 66 feet, more or less, to the north westerly corner of Lot "A" aforesaid. Thence N.89°49'E. and following the northerly boundary of said Lot "A" a distance of 122.13 feet, more or less, to the point of commencement as shown outlined in red on the plan attached hereto."

is hereby stopped up and closed to traffic.

3. The Reeve and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon that portion of Napier Street more particularly hereinbefore described and vest title thereto in The Corporation of the District of Burnaby.

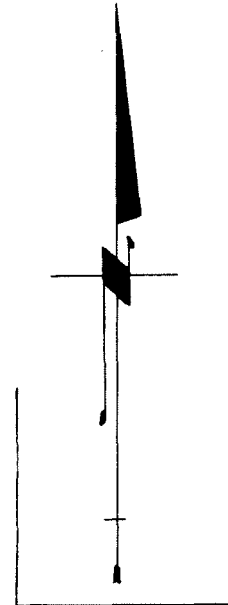
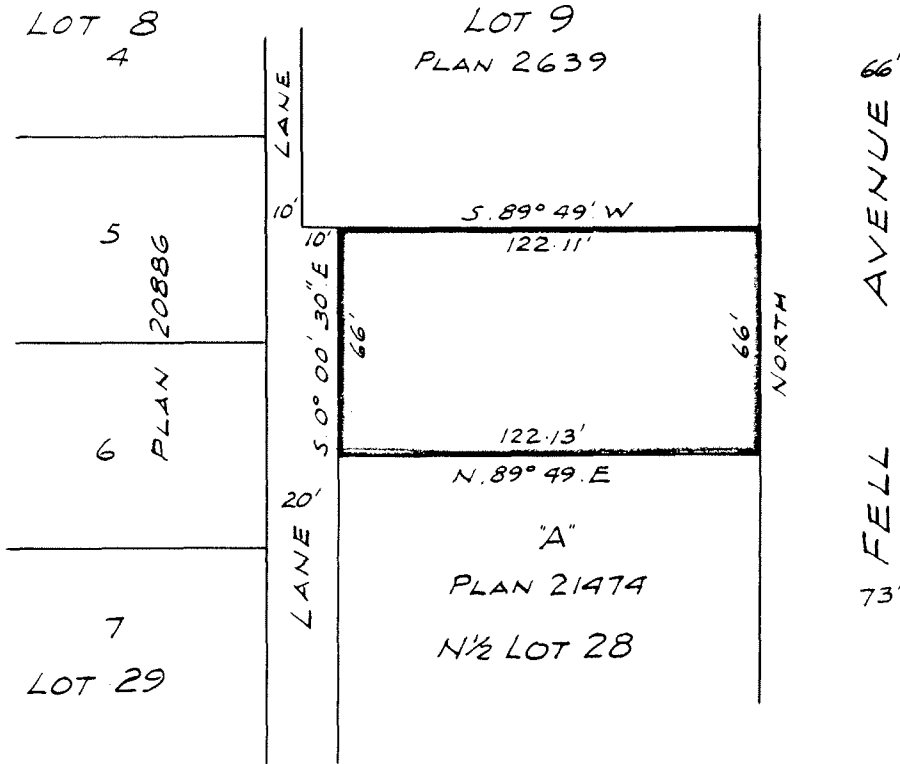
