BY-LAW NO. 4208

A BY-LAW to amend By-law 1991, being  
"Burnaby Town Planning By-law 1948"

WHEREAS application for rezoning has been made to  
the Council.

AND WHEREAS the Council has held a public hearing  
thereon after duly giving notice of the time and place of  
such hearing.

NOW THEREFORE The Council of The Corporation of the  
District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY TOWN PLANNING  
BY-LAW 1948, AMENDMENT BY-LAW NO. 9, 1960".

2. Part 3 of Schedule 1 to "Burnaby Town Planning By-law  
1948", being By-law 1991, is amended by adding the following  
as clause (11):

"(11) Lots 19 and 20 Block 16 of Lot 186 Group 1  
Plan 1124 New Westminster District."

3. Part 4 of Schedule 1 is amended by adding the following  
as clause (t):

"(t) Lot "B" of Blocks 14 to 16 of the North part  
of Lot 95 Group 1 Plan 21955 New Westminster  
District."

4. Schedule 3 is amended by adding the following as  
clauses (65) and (66):

"(65) All that area bounded on the South by  
Hastings Street, on the East by the lane  
West of Delta Avenue, on the North by the  
lane North of Hastings Street, and on the  
West by Gamma Avenue.

(66) All that area bounded on the North by  
Hastings Street, on the West by Gamma  
Avenue, and on the South by the lane South  
of Hastings Street."

5. Schedule 3 is further amended by deleting the following therefrom:

- "(a) Lots "C" and "D" and "E" Block 6 of the North East Quarter of Lot 149 Group 1 Plan 7988 New Westminster District.
- (b) Lots 1 to 5 inclusive Block 7 of the North East Quarter of Lot 149 Group 1 Plan 9140 New Westminster District."

6. Schedule 5 is amended by deleting the following therefrom:

- "(a) The East part of Lots 10, 11, 12 and 13 Block "J" of Lot 96 Group 1 Plan 3907 New Westminster District.
- (b) Lot "L" Explanatory Plan 14041 Block "J" of Lot 96 Group 1 Plan 3907 New Westminster District."

7. Schedule 11 is amended by adding the following as clauses 14 and 15:

- "(14) Lots 2, 3 and 5 Block "J" and 27 of Lot 97 Group 1 Plan 21397 New Westminster District.
- (15) Lot 7 Blocks 21 and 28 of Lot 97 Group 1 Plan 22309 New Westminster District."

Read a first time this 19th day of December, 1960.

Read a second time this 19th day of December, 1960.

Read a third time this 19th day of December, 1960.

Reconsidered and adopted by a two-thirds vote of all the members of the Council this 28th day of December, 1960.
