

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4280

A BY-LAW to establish certain lands as a public highway.

WHEREAS The Corporation is desirous of widening a portion of Hastings Street and for such purpose requires, among other lands, those hereinafter described.

AND WHEREAS The Corporation has negotiated or is in the course of negotiating with the owners of the said lands for the acquisition thereof:

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD DEDICATION BY-LAW 1961".
2. Upon the registration of title in fee simple, free and clear of all encumbrances, in The Corporation to any or all of the following described lands same shall be and are hereby established as a public highway, namely:
