

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4282

A BY-LAW to authorize the expropriation of certain real property.

WHEREAS it is deemed necessary and in the public interest to expropriate the real property hereinafter described in order to widen Moscrop Street in the Municipality of Burnaby and to construct and install therein necessary municipal works and services.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY HIGHWAY EXPROPRIATION BY-LAW NO. 2, 1961".

2. In order to widen Moscrop Street and to construct and install therein necessary municipal works and services, The Corporation of the District of Burnaby is hereby authorized and empowered, without the consent of the owners of the real property but subject to the provisions of Division (4) of Part XII of the Municipal Act:-

(a) By its servants and agents to enter upon, expropriate, break up, take or enter into possession of or use that portion of Lot "A" of Lots 34 and 35, Group 1, New Westminster District, Plan 5487, more particularly described as follows:

"Commencing at a point on the northerly boundary of said Lot "A", Plan 5487, distant Sixteen and a half (16.5) feet on a bearing of South zero degree and twenty-four minutes west (S 0°24'W) from a point on the northerly boundary of said Lot Thirty-four (34) which said point is distant One Hundred thirty-eight and seventy-nine hundredths (138.79) feet, more or less, easterly from the north-west corner of said Lot Thirty-four (34); thence South zero degree and nine

minutes west (S 0° 09' W) and parallel to the easterly boundary of said Lot "A", Sixteen and a half (16.5) feet; thence South eighty-nine degrees and thirty-six minutes east (S 89° 36' E) and parallel to the northerly boundary of said Lot Thirty-four (34), three hundred fifty-three and fifty-nine hundredths (353.59) feet, more or less, to a point on the easterly boundary of said Lot "A"; thence North zero degree and nine minutes east (N 0° 09' E) along said easterly boundary, sixteen and a half (16.5) feet, more or less, to the northeast corner of said Lot "A"; thence North eighty-nine degrees and thirty-six minutes west (N89° 36' W) and parallel to the northerly boundary of said Lot Thirty-four (34), three hundred fifty-three and fifty-nine hundredths (353.59) feet, more or less, to the point of commencement; all said bearings are Astronomic and are referred to the meridian of Plan 22777; the said parcel containing Five thousand and eight hundred thirty-four square feet (5834 square feet), more or less, as shown outlined in red colour on the plan prepared by K. K. Wong, B.C.L.S., and dated the 7th day of September, 1961."

(b) By its servants and agents to enter upon any real property which may be injuriously affected by the exercise of any of the aforesaid powers for the purpose of executing any works of construction, maintenance, or repair in mitigation of injuries done or apprehended or in reduction of compensation.

3. This By-law shall, before coming into effect, be published once in the B. C. Gazette and in a newspaper published or circulating in the Municipality of Burnaby and

a certified copy of the by-law shall be filed in the
Land Registry Office in the City of New Westminster, in
the Province of British Columbia.
