A BY-LAW to assign a name to certain highways within the municipality.

The Council of The Corporation of the District of Burnaby ENACTS as follows:-

l. This by-law may be cited as "BURNABY STREET NAMING BY-LAW 1961".

2. There is hereby assigned to the highways designated in Schedule "A" to this by-law the names therein respectively set forth.

The Council does hereby change the name of:

- (a) Cedarwood Crescent to Cedarwood Court
- (b) Summer Avenue to Beta Avenue
- (c) Brentwood Street to Burnwood Street

4. This by-law shall have no force or effect unless and until a certified copy hereof is filed in the Land Registry Office in the City of New Westminster, Province of British Columbia.
