

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4314

A BY-LAW to establish certain lands as public highway.

WHEREAS The Corporation has acquired the hereinafter described lands for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD DEDICATION BY-LAW NO. 2, 1961".
2. Those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly described as follows, namely:
 - (a) A portion of Lot 46 of part of the North Half of Lot 80 Group 1 Plan 10063 New Westminster District, described as follows:

Commencing at the southeast corner of said Lot Forty-six (46), Plan 10063; thence North Eighty-nine degrees and thirty-one minutes west (N89°31'W) along the southerly boundary of said lot, fifty-four and seventy-five hundredths (54.75) feet; thence North fifty-nine degrees one minute and forty seconds east (N59°01'40"E), twenty-nine and twenty-two hundredths (29.22) feet; thence North three degrees fifty-three minutes and ten seconds west (N3°53'10"W), twenty-nine and twenty-two hundredths (29.22) feet, more or less, to a point on the northeasterly boundary of said lot, situate distant fifty-four and seventy-five hundredths (54.75) feet north-westerly from the said southeast corner thereof; thence South thirty-five degrees twenty minutes and thirty seconds east (S35°20'30"E) along the said northeasterly boundary, fifty-four and seventy-five hundredths (54.75) feet to the point of commencement; all said bearings are Astronomic and are referred to the meridian of Plan 10063 and said parcel containing Eight hundred thirty-five (835) square feet, more or less, as shown outlined Red on reference Plan No. 23710.

- (b) A portion of Lot 6 Block 1 of Lot 98 Group 1 Plan 4359 New Westminster District, described as follows:

Commencing at the northeast corner of said Lot Six (6), Plan 4359; thence North Eighty-nine degrees and forty-six Minutes west (N89°46'W) along the northerly boundary of said lot, forty (40) feet; thence South Eighty-two degrees forty minutes and forty seconds east (S82°40'40"E), forty and forty-nine hundredths (40.49) feet, more or less, to a point on the easterly boundary of said Lot Six (6) which said point is situate distant Five (5) feet southerly from the said northeast corner thereof; thence North One degree fifty-one minutes and thirty seconds west (N1°51'30"W) along the said easterly boundary, five (5) feet to the point of commencement; all the said bearings are Astronomic and are derived from the meridian referred to Plan 4359; the said parcel containing one hundred (100) square feet, more or less, as shown outlined Red on Plan 23776.

- (c) The North Ten feet of Lot 26 of Blocks 24 and 25 of Lot 159 Group 1 Plan 1268 New Westminster District.

are hereby established as public highways or portions thereof.
