BY-LAW NO. 4316

A BY-LAW to levy a special assessment pursuant to the Special Surveys Act.

WHEREAS a special survey has been undertaken in the North Half of Block 19 of Lot 27 Group 1 Municipality of ^Burnaby, New Westminster District.

AND WHEREAS amounts for costs, expenses, fees and compensation have been charged by the terms of the Orderin-Council of the Lieutenant-Governor in Council against the registered owners of certain of the parcels shown on the plan of special survey.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY SPECIAL SURVEY ASSESSMENT BY-LAW 1961".

2. There is hereby assessed and levied against those parcels of land described in Schedule "A" hereto the respective amounts set opposite the description of each parcel.

3. The amounts hereby assessed shall be payable in one payment on or before the 31st day of December, 1962, with the exception of the amount assessed against Lot 18 of Block 19 of Lot 27 Group 1 Plan 1077 New Westminster District, which, together with interest on the principal balance from time to time remaining unpaid, shall be payable in ten annual instalments in each of the years 1962 to 1971, both inclusive.
