BY-LAW NO. 4367

A BY-LAW to authorize The Corporation to bear an additional share of the cost of certain local improvement works pursuant to Section 597 of the Municipal Act.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY LOCAL IMPROVEMENT COST SHARING BY-LAW 1962".
2. Notwithstanding anything contained in Section 595 or 596 of the Municipal Act or in By-law No. 4156 The Corporation of the District of Burnaby shall bear that portion of the cost of the local improvement works more particularly described in the said by-law which exceeds \$6.990 per taxable front foot.
3. Notwithstanding anything contained in Section 595 or 596 of the Municipal Act or in By-law No. 4193 The Corporation of the District of Burnaby shall bear that portion of the cost of the local improvement works more particularly described in the said by-law which exceeds \$6.154 per taxable front foot.
4. Notwithstanding anything contained in Section 595 or 596 of the Municipal Act or in By-law No. 4194 The Corporation of the District of Burnaby shall bear that portion of the cost of the local improvement works more particularly described in the said by-law which exceeds \$7.556 per taxable front foot.
5. Notwithstanding anything contained in Section 595 or 596 of the Municipal Act or in By-law No. 4286 The Corporation of the District of Burnaby shall bear that portion of the cost of the local improvement works more particularly described in the said by-law which exceeds \$5.352 per taxable front foot.

6. Notwithstanding anything contained in Section 595 or 596 of the Municipal Act or in By-law No. 4287 The Corporation of the District of Burnaby shall bear that portion of the cost of the local improvement works more particularly described in the said by-law which exceeds \$6.045 per taxable front foot.

7. Notwithstanding anything contained in Section 595 or 596 of the Municipal Act or in By-law No. 4288 The Corporation of the District of Burnaby shall bear that portion of the cost of the local improvement works more particularly described in the said by-law which exceeds \$4.275 per taxable front foot.

8. Notwithstanding anything contained in Section 595 or 596 of the Municipal Act or in By-law No. 4289 The Corporation of the District of Burnaby shall bear that portion of the cost of the local improvement works more particularly described in the said by-law which exceeds \$6.998 per taxable front foot.

9. Notwithstanding anything contained in Section 595 or 596 of the Municipal Act or in By-law No. 4257 The Corporation of the District of Burnaby shall bear that portion of the cost of the local improvement works more particularly described in the said by-law which exceeds \$4.450 per taxable front foot.

10. Notwithstanding anything contained in Section 595 or 596 of the Municipal Act or in By-law No. 4259 The Corporation of the District of Burnaby shall bear that portion of the cost of the local improvement works more particularly described in the said by-law which exceeds \$4.450 per taxable front foot.

11. By-laws numbered 4156, 4193, 4194, 4286, 4287, 4288, 4289, 4257, 4259, and Schedules "C", "H", "I", "M", "N", "O", "P", "S" and "T" of By-law No. 4355 are hereby amended to the extent necessary to give effect to this by-law.
