BY-LAW NO. 4371

A BY-LAW to authorize the expenditure of \$11,419.14 being the balance remaining after construction of the waterworks authorized by By-Law No. 3659.

WHEREAS By-Law No. 3082, being the "Burnaby Waterworks Loan By-Law 1950", authorized the construction of the certain waterworks defined therein and the borrowing of \$892,000.00 therefor by the issue and sale of debentures.

AND WHEREAS By-Law No. 3409, being the "Burnaby Waterworks Loan By-Law 1953", authorized the construction of the certain waterworks defined therein and the borrowing of \$1,220,000.00 therefor by the issue and sale of debentures.

AND WHEREAS after the said waterworks had been constructed and the cost thereof fully paid there remained unexpended the sum of \$2,352.18 in the By-Law No. 3082 fund and the sum of \$204,349.82 in the By-Law No. 3409 fund.

AND WHEREAS By-Law No. 3659, being the "Burnaby Waterworks Construction By-Law 1955", authorized the expenditure of the said unexpended balances of \$2,352.18 and \$204,349.82 for the purpose of replacing, renewing, repairing and improving the existing main water supply line serving the central low pressure area of the Municipality along the route described in the said by-law.

AND WHEREAS the said waterworks authorized by By-Law No. 3659 have been constructed and the cost thereof fully paid.

AND WHEREAS there remains unexpended the sum of \$11,419.14 in the said By-Law No. 3659 fund.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-Law may be cited as "BURNABY WATERWORKS CONSTRUCTION BY-LAW 1962."

2. The Council is hereby authorized and empowered to expend the sum of \$11,419.14, being the unexpended balance in the By-Law No. 3659 fund for the construction of the following waterworks:

(a) A 6" main on Oxford Street from Delta Avenue west a distance of 250 feet approximately

(b) An 8" main across the Lougheed Highway at Bell Avenue for a distance of 200 feet approximately

(c) An 8" main on the Barnet Highway in the vicinity of Arden Street for a distance of 860 feet approximately.

3. This By-law shall, before the final adoption thereof, receive the approval of the Inspector of Municipalities.

Read a first time this 11th day of June, 1962.

Read a second time this 11th day of June, 1962.

Read a third time this 11th day of June, 1962.

Received the approval of the Inspector of Municipalities this 26th day of June, 1962.

Reconsidered and adopted this 3rd day of July, 1962.
