## BY-LAW NO. 4373

A BY-LAW to acquire certain lands for highway purposes.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD ACQUISITION AND DEDICATION BY-LAW NO. 5, 1962".
2. The Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from the registered owner thereof by a good and sufficient deed in fee simple, free and clear of all encumbrances, for highway purposes, in consideration of the sum of one ( $\$ 1.00$ ) Dollar and other valuable consideration those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being a portion of Lot "E", Block 13 of Lot 159, Group 1, Plan 13075, New Westminster District which may be more particularly described as follows:

the northerly boundary of said lot, ten (10) feet;

> hundredths ( 28.02 ) feet, more or less, to the point of commencement; all the said bearings are Astronomic and are derived from the meridian referred to Plan Twelve thousand four hundred and thirty ( 12430 ); the said parcel containing Two hundred ninety-three ( 293 ) square feet, more or less, as shown outlined red on the plan attached hereto."
3. Upon registration of the said deed in fee simple in the Land Registry Office in the City of New Westminster, In the Province of British Columbia, the said lands shall be established as a public highway.
