> A BY-LAW to levy a special assessment against certain parcels of land within the Municipality pursuant to the "Special Surveys Act".

WHEREAS a special survey has been undertaken pursuant
to the "Special Surveys Act" of Lots 1, 2, 5 and 6 of the southerly portion of Lot 28, Group 1, New Westminster District, and roads adjoining said lots as shown on Plan 274.

AND WHEREAS amounts for costs, expenses and fees have been charged by the terms of Order-in-Council No. 236 approved January 29th, 1962 against the registered owners of certain of the parcels shown on the plan of special survey now deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia and numbered 24032.

AND WHEREAS the Council shall by by-law specially assess those parcels for the amounts so charged against them respectively.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. This By-law may be cited as "BURNABY SPECIAL SURVEY ASSESSMENT BY-LAW 1962".
2. (1) There is hereby specially assessed and levied against each parcel of land described in Column 1 of Schedule "A" hereunto annexed the amount set out opposite thereto in Column 2 of the said schedule.
(2) If the said amount is less than $\$ 50.00$ it shall be paid in 1962 in one instalment and if more than $\$ 50.00$ it may be paid in annual instalments of $\$ 50.00$ commencing in 1962.
3. All the provisions of the Municipal Act and any bylaw passed pursuant thereto applicable to the collection and recovery of taxes in the municipality and the proceedings which may be taken in default of payment thereof shall apply to the special assessment and all amounts payable thereunder.
