

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4531

A BY-LAW to acquire certain lands for highway purposes.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD ACQUISITION AND DEDICATION BY-LAW NO. 2, 1964".

2. The Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from the registered owners thereof by a good and sufficient deed in fee simple, free and clear of all encumbrances, for highway purposes, in consideration of the sum of One (\$1.00) Dollar and other good and valuable consideration, those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as:

- (a) The South five feet of Lot 3, Block 4 of the East Half of Lot 158, Group 1, Plan 1501, New Westminster District.
- (b) The South five feet of Lot 4, Block 4 of the East Half of Lot 158, Group 1, Plan 1501, New Westminster District.
- (c) The South five feet of Lot 5, Block 4 of the East Half of Lot 158, Group 1, Plan 1501, New Westminster District.
- (d) The South five feet of Lot 6, Block 4 of the East Half of Lot 158, Group 1, Plan 1501, New Westminster District.
- (e) The South five feet of Lot 7, Block 4 of the East Half of Lot 158, Group 1, Plan 1501, New Westminster District.
- (f) The North two feet of Lot 22, Block 4 of the East Half of Lot 158, Group 1, Plan 11705, New Westminster District.
- (g) The North two feet of Lot 23, Block 4 of the East Half of Lot 158, Group 1, Plan 11705, New Westminster District.

- (h) The North two feet of Lot 24, Block 4 of the East Half of Lot 158, Group 1, Plan 11705, New Westminster District.
- (i) The North two feet of Lot 25, Block 4 of the East Half of Lot 158, Group 1, Plan 11705, New Westminster District.
- (j) The North two feet of Lot 26, Block 4 of the East Half of Lot 158, Group 1, Plan 11705, New Westminster District.
- (k) The North two feet of Lot 27, Block 4 of the East Half of Lot 158, Group 1, Plan 11705, New Westminster District.
- (l) The North two feet of Lot 28, Block 4 of the East Half of Lot 158, Group 1, Plan 11705, New Westminster District.
- (m) The North two feet of Lot "G" of Blocks 3 and 4 of Lot 158, Group 1, Plan 22253, New Westminster District.

3. Upon registration of the said deeds in fee simple in the Land Registry Office in the City of New Westminster, in the Province of British Columbia, the said lands shall be established as a public highway.
