

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4709

A BY-LAW to amend By-Law No. 3926, being
"Burnaby Parks Commission By-Law
1957".

The Council of The Corporation of the District of Burnaby

ENACTS as follows:

1. This By-law may be cited as "BURNABY PARKS COMMISSION BY-LAW 1957, AMENDMENT BY-LAW 1965".

2. By-law No. 3926 is amended by adding the following as Section 3A:

"3A. (1) Notwithstanding anything contained in By-law No. 3926 or By-law No. 4323, Council shall make all appointments to the Commission at its first meeting in January of each year.

(2) Members of the Commission whose appointments presently terminate on the 31st day of January, 1966 and on the 31st day of January, 1967 shall cease to be members of the Commission immediately prior to the first meeting of Council in January, 1966 and in January, 1967 respectively."

3. By-law No. 3926 is further amended by adding the following as Section 3B:

"3B . Any member of Council appointed as a member of the Commission shall continue as a member of the Commission only so long as he shall be a member of the Council."

4. Section 4 of By-law No. 3926 is repealed and the following substituted therefor:

"4. (1) Each member of the Commission shall be an owner-elect on the list of electors for that year in which he is appointed and for the immediately preceding year.

(2) Whenever a member of the Commission ceases to be an owner-elect he shall forthwith cease to be a member of the Commission."

5. Section 9 of By-law No. 3926 is repealed and the following substituted therefor:

"9. The Commission shall at its first meeting in January of each year appoint one of its members, who shall not be a member of Council, as Chairman. The Chairman shall preside at the meetings of the Commission when present, and in his absence an Acting Chairman may be appointed. The Commission shall at the same meeting appoint a secretary."

6. Section 10 of By-law No. 3926 is repealed and the following substituted therefor:

"10. (1) The Commission shall hold regular meetings twice in each month, except in July and August, at such time and place within the Municipality as it may appoint.

(2) In July and August the Commission shall meet at the call of the Chairman.

(3) At all meetings of the Commission, four members shall constitute a quorum."

7. Section 12 of By-law No. 3926 is repealed and the following substituted therefor:

"12. (1) The Chairman shall appoint such committees as may be deemed necessary by the Commission.

(2) A majority of any committee shall constitute a quorum.

(3) Section 13 shall apply to meetings of any committee appointed pursuant to this section."

8. Section 16 of By-law No. 3926 is repealed and the following substituted therefor:

"16. Except as otherwise provided in this By-law, the Commission shall by resolution establish rules of procedure governing the conduct of its meetings."
