

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4926

A BY-LAW to acquire certain lands for highway purposes.

The Council of The Corporation of Burnaby ENACTS
as follows:

1. This By-law may be cited as "BURNABY ROAD ACQUISITION AND DEDICATION BY-LAW NO. 9, 1966".

2. The Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from the registered owners thereof by a good and sufficient deed in fee simple, free and clear of all encumbrances, for highway purposes, in consideration of the sum of One (\$1.00) Dollar and other good and valuable consideration, those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as follows:
 - (1) The 50.0 square foot portion of Lot Eight (8) of the North Half of Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 6718, New Westminster District, as shown outlined in red on plan attached hereto;
 - (2) The 271.0 square foot portion of Lot "C", Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 13908, New Westminster District, as shown outlined in red on plan attached hereto;
 - (3) The 468.0 square foot portion of Lot "D" of the South Half of Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 13908, New Westminster District, as shown outlined in red on plan attached hereto;
 - (4) The 242.0 square foot portion of Lot Eight (8) of the South Half of Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 1190, New Westminster District, as shown outlined in red on plan attached hereto;
 - (5) The 240.0 square foot portion of Lot Nine (9), Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 1190, New Westminster District, shown outlined in red on plan attached hereto;

- (6) The 238.0 square foot portion of Lot Ten (10) of the South Half of Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 1190, New Westminster District, shown outlined in red on plan attached hereto;
- (7) The 236.0 square foot portion of Lot Eleven (11) of the South Half of Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 1190, New Westminster District, as shown outlined in red on plan attached hereto;
- (8) The 234.0 square foot portion of Lot Twelve (12) of the South Half of Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 1190, New Westminster District, shown outlined in red on plan attached hereto;
- (9) The 232.0 square foot portion of Lot Thirteen (13) of the South Half of Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 1190, New Westminster District, as shown outlined in red on plan attached hereto;
- (10) The 230.0 square foot portion of Lot Fourteen (14) of the South Half of Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 1190, New Westminster District, as shown outlined in red on plan attached hereto;
- (11) The 228.0 square foot portion of Lot Fifteen (15), of the South Half of Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 1190, New Westminster District, shown outlined in red on plan attached hereto;
- (12) The 135.0 square foot portion of Lot Nineteen (19), Block Twenty-nine (29), Lot One Hundred Fifty-nine (159), Group 1, Plan 1190, New Westminster District, as shown outlined in red on plan attached hereto.

3. Upon registration of the said deeds in fee simple in the Land Registry Office in the City of New Westminster, Province of British Columbia, the said lands shall be established as a public highway.
