

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4956

A BY-LAW to assign a name to certain highways within the municipality.

The Council of The Corporation of the District of Burnaby  
ENACTS as follows:

1. This By-law may be cited as "BURNABY STREET NAMING BY-LAW 1966".
2. The highways more particularly designated in Schedule "A" annexed hereto are hereby assigned the names therein respectively set forth.
3. The Council does hereby change the name of that portion of highway now known as Curragh Avenue, extending south from Bryant Street between Waltham Avenue and Randolph Avenue, to St. Charles Place.
4. This by-law shall have no force or effect unless and until a certified copy hereof is filed in the Land Registry Office in the City of New Westminster, Province of British Columbia.

<u>STREET</u>	<u>LOCATION</u>
<u>BLAINE PLACE</u>	First street East of Cliff Avenue, North from Curtis Street.
<u>BLAINE COURT</u>	East from the Northerly termination of Blaine Place.
<u>BURNLAKE DRIVE</u>	First street South of Government Street, East from Piper Avenue.
<u>CHAPPLE CRESCENT</u>	First street West of Iris Avenue, South from Gilpin Street.
<u>ELLERTON COURT</u>	East from Willingdon Avenue between Burke Street and Bond Street.
<u>EVERETT CRESCENT</u>	First street South of Union Street, West from Duthie Avenue.
<u>EXPRESS STREET</u>	First street North of Venture Street, East from Lake-City Way.
<u>HAMBRY STREET</u>	East from Waltham Avenue between Imperial Street and Bryant Street.
<u>HUNTER COURT</u>	North from the Westerly termination of Hunter Street.
<u>MOUNTVIEW PLACE</u>	First street East of Noel Drive, North from Lyndhurst Street.
<u>SHERRITT COURT</u>	First street North of Curtis Street, East from Blaine Place.
<u>TARALAWN COURT</u>	First street North of Halifax Street, East from Delta Avenue.
<u>VANSON AVENUE</u>	First street East of Piper Avenue, South from Government Street.
<u>WAKEFIELD COURT</u>	First street North of Moscrop Street, West from Smith Avenue.
<u>WINLAKE CRESCENT</u>	First street East of Piper Avenue, South from Burnlake Drive.
<u>YEOVIL PLACE</u>	East from the South end of Yeovil Avenue.
