

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5001

A BY-LAW to acquire certain lands for highway purposes.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD ACQUISITION AND DEDICATION BY-LAW NO. 17, 1966".

2. The Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from the registered owners thereof by a good and sufficient deed in fee simple, free and clear of all encumbrances, for highway purposes, in consideration of the sum of One (\$1.00) Dollar and other good and valuable consideration, those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being a portion of Lot Sixteen (16), Block Eight (8) of Lot Ninety-seven (97), Group One (1), Plan 1627, New Westminster District, which said portion may be more particularly described as follows:

Commencing at the Northwesterly corner of said Lot 16, Plan 1627;

Thence S.64°20'40"E. along the Northeasterly boundary of said Lot 16, 20 feet;

Thence S.57°50'50"W., 21.31 feet, more or less, to a point of intersection with the Westerly boundary of said Lot 16, said point situate distant 20 feet, measured southerly from said northwesterly corner thereof;

Thence N.0°02'20"E. along said Westerly boundary, 20 feet to the point of commencement;

All the said bearings are Astronomic and are derived from the meridian referred to Plan 1627, Buller Avenue being due Astronomic North; and said parcel containing 180 square feet, more or less, as shown outlined in red on plan prepared by Edmund T. Wong, B.C.L.S., dated the 11th day of October, 1966, a copy of which is attached hereto.

3. Upon registration of the said deed in fee simple in the Land Registry Office at the City of New Westminster, in the Province of British Columbia, the said lands shall be established as a

public highway.

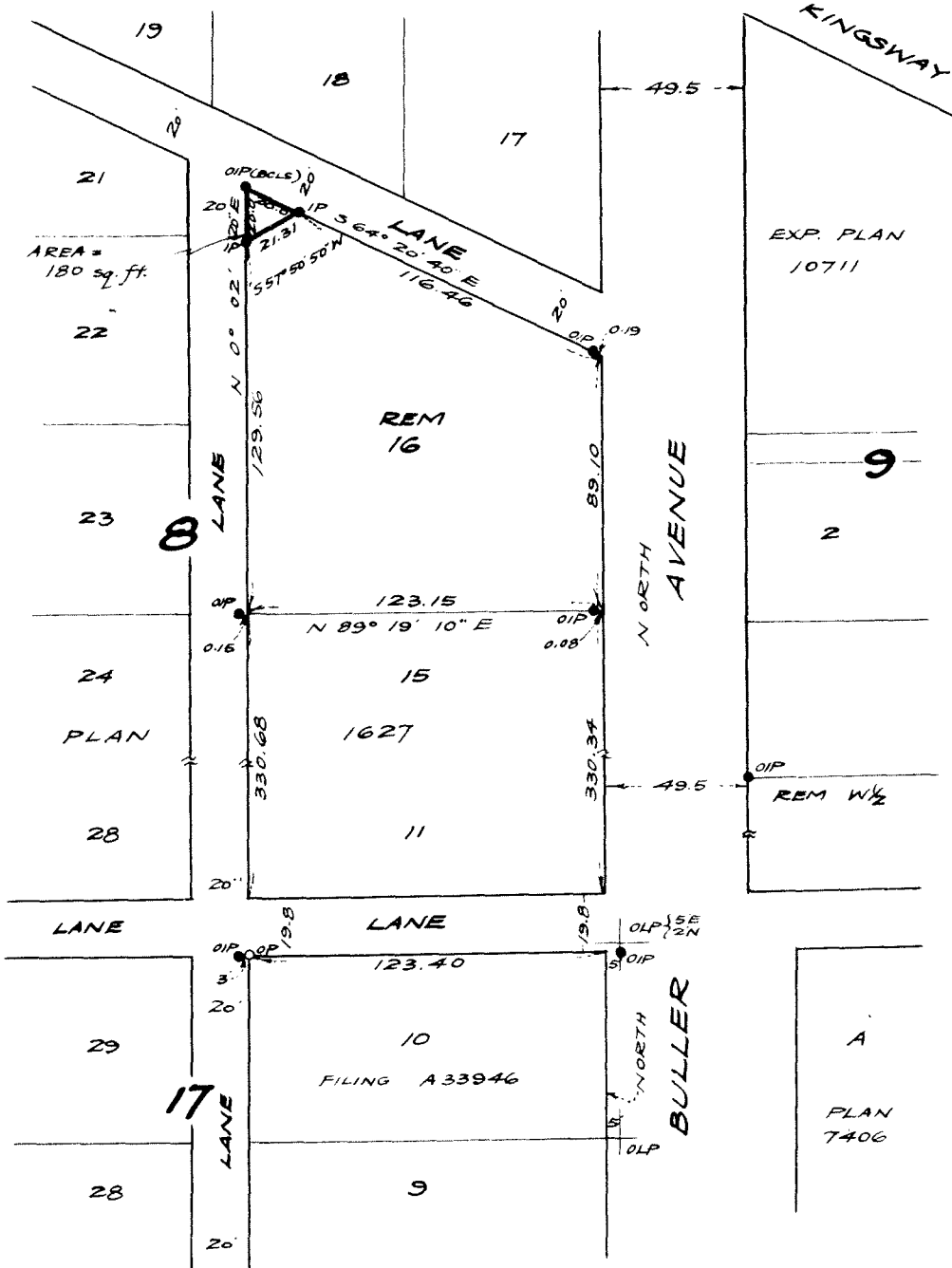
