

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5053

A BY-LAW to Stop Up and Close to Traffic
a Portion of Road.

WHEREAS that portion of road shown outlined red on Plan annexed hereto was established as highway by those certain plans deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under Nos. 824 and 3439.

AND WHEREAS the said portion of road is no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD CLOSING BY-LAW 1967".
2. That portion of road (hereinafter called "the said portion"), being all and singular that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as a portion of District Lot 97, Group 1, Plans 824 and 3439, New Westminster District, which portion may be more particularly described as follows:

Commencing at the Southeasterly corner of Lot 1, according to Plan 3439, deposited;

Thence S.0°17'E., and following the Southerly prolongation of the Easterly boundary of the said Lot 1, 33.0 feet, more or less, to the Northeasterly corner of Lot 42, according to Plan 27404 deposited;

Thence S.89°22'W. and following a portion of the Northerly boundary of said Lot 42, a distance of 195.03 feet, more or less, to the Southeasterly corner of Lot 39, according to Plan 26864 deposited;

Thence N.0°04'30"W., 33.0 feet, more or less, to the Southwesterly corner of Lot 1, aforesaid;

Thence N.89°22'E., 194.91 feet, and following the Southerly boundary of Lot 1 aforesaid to the point of commencement and containing by estimation 0.148 of an acre, be the same, more

or less, as shown outlined red on Plan prepared by P. Aplin, B.C.L.S., dated the 22nd day of December, 1966, a copy of which is hereunto attached.

is hereby stopped up and closed to traffic.

3. The Reeve and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portions and vest title thereto in The Corporation of the District of Burnaby.

PLANS 824 AND 3439, DISTRICT LOT 97, GROUP 1.

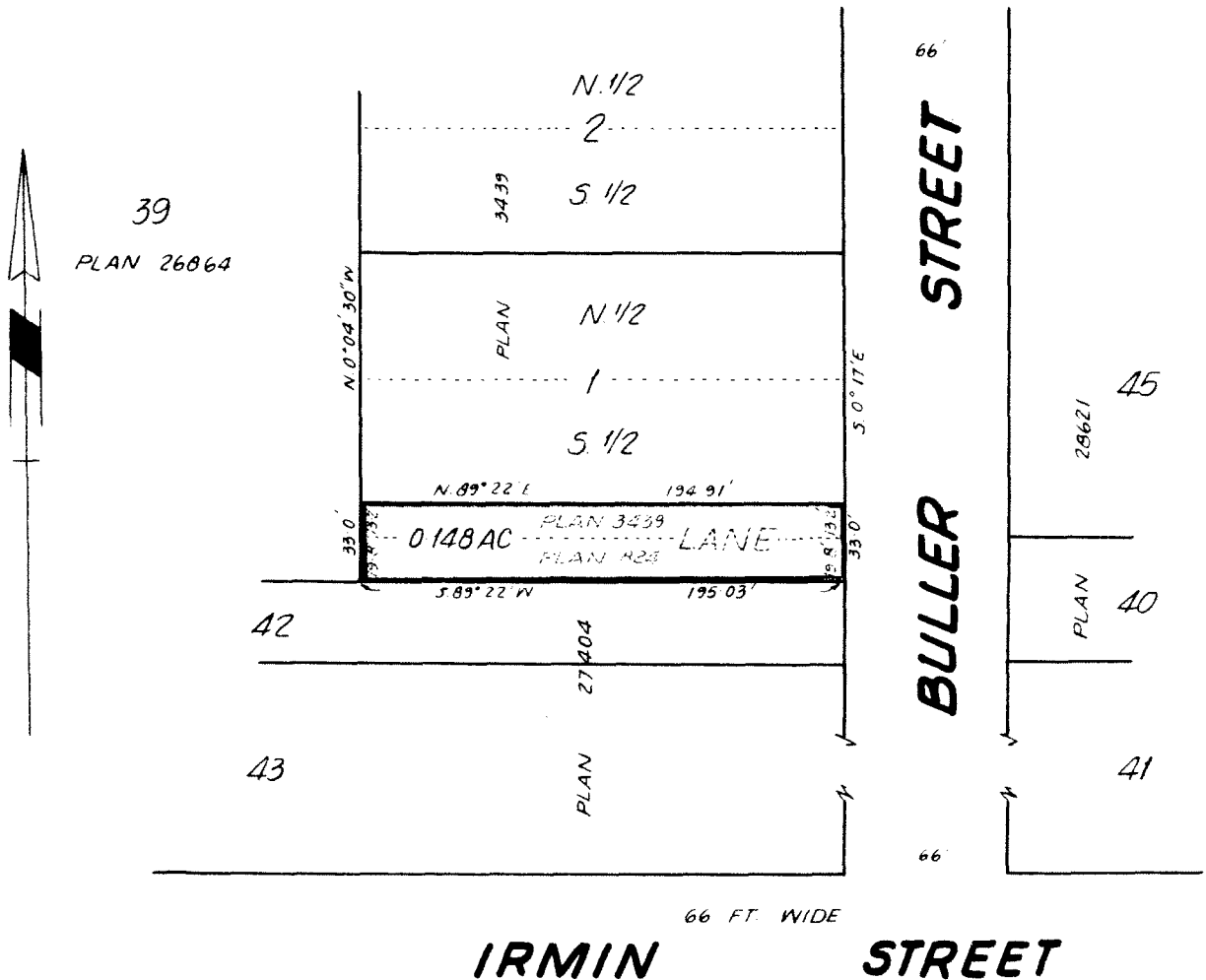
