

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5090

A BY-LAW to Stop Up and Close to Traffic
Portions of Roads.

WHEREAS those portions of roads shown outlined red on Plan annexed hereto were established as highway by that certain plan deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under No. 3023.

AND WHEREAS the said portions of roads are no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-Law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 2, 1967".
2. Those portions of roads (hereinafter called the "said portions"), being all and singular those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as portions of 16th Street, 17th Street, 14th Avenue and 15th Avenue, all in District Lot 53, Group 1, Plan 3037, which said portions may be more particularly described as follows:
 - (a) Being that portion of 15th Avenue lying between 19th Street and 18th Street, in District Lot 53, Group 1, New Westminster District, Plan 3037;
 - (b) Being that portion of 14th Avenue lying between 19th Street and 18th Street, in District Lot 53, Group 1, New Westminster District, Plan 3037;
 - (c) Being that portion of 14th Avenue lying between 18th Street and 15th Street, in District Lot 53, Group 1, New Westminster District, Plan 3037;

(d) Being that portion of 15th Avenue lying between 18th Street and 15th Street, in District Lot 53, Group 1, New Westminster District, Plan 3037;

(e) Being that portion of 17th Street lying between 14th Avenue and 15th Avenue, in District Lot 53, Group 1, New Westminster District, Plan 3037;

(f) Being that portion of 16th Street, lying between 14th Avenue and 15th Avenue, in District Lot 53, Group 1, New Westminster District, Plan 3037;

(g) Being that portion of 17th Street lying between 15th Avenue and the Southwesterly production of the Southeasterly boundary of Lot "A", Plan 3037;

(h) Being that portion of 16th Street lying between 15th Avenue and the Southwesterly production of the Southerly boundary of Lot "A", Plan 3037;

all of the aforementioned areas being shown outlined in red on plan prepared by C. D. Underhill, B.C.L.S., dated the 28th day of February, 1967, and marked Parcels "A" to "H" respectively, a copy of which is hereunto annexed, are hereby stopped up and closed to traffic.

3. The Reeve and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portions and vest title thereto in The Corporation of the District of Burnaby.
