

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5134

A BY-LAW to Stop Up and Close to Traffic
a Portion of Road.

WHEREAS that portion of road shown outlined red
on Plan annexed hereto was established as highway by that certain
plan deposited in the Land Registry Office at the City of New
Westminster, Province of British Columbia, under number 1413.

AND WHEREAS the said portion of road is no longer
required for highway purposes.

NOW THEREFORE the Council of The Corporation of
the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD CLOSING
BY-LAW NO. 3, 1967".
2. That portion of road (hereinafter called "the said
portion"), being all and singular that certain parcel or tract
of land and premises situate, lying and being in the Municipality
of Burnaby, in the Province of British Columbia, and being more
particularly known and described as a portion of District Lot 70,
Group 1, Plan 1413, New Westminster District, which portion may
be more particularly described as follows:

Commencing at the Northwesterly corner of the East
149.0 feet of the East one half of Lot 2, Block 14,
according to Plan 3824 deposited;

Thence Northwardly and following the Northwardly
prolongation of the Westerly boundary of the East
149.0 feet of the East one half of Lot 2, aforesaid,
66.01 feet, more or less, to an intersection with
the Southerly boundary of the East 569.25 feet of
Lot "A" of Block 11, according to Plan 9892 deposited;

Thence Eastwardly and following the Southerly boundary
of the East 569.25 feet of Lot "A" of Block 11, afore-
said, 134.00 feet, more or less, to a point, said
point lying Westwardly and 15.00 feet distant from
the Southeasterly corner thereof;

Thence Southwardly 66.01 feet, more or less, to a
point on the Northerly boundary of the East 149.0
feet of the East one half of Lot 2, aforesaid, said
point lying Westwardly and 14.00 feet distant from
the Northeasterly corner thereof;

Thence Westwardly and following the Northerly boundary of the East 149.0 feet of the East one half of Lot 2, aforesaid, 135.00 feet, more or less, to the point of commencement, and containing by estimation 0.204 of an acre, be the same, more or less, as shown outlined red on Plan prepared by D. S. Black, B.C.L.S., dated the 20th day of April, 1967, a copy of which is hereunto annexed.

is hereby stopped up and closed to traffic.

3. The Reeve and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portions and vest title thereto in The Corporation of the District of Burnaby.
