

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5143

A BY-LAW to authorize the expropriation of certain real property.

WHEREAS it is deemed necessary and in the public interest to expropriate the real property hereinafter described for highway purposes and to construct and install thereon necessary municipal works and services.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY HIGHWAY EXPROPRIATION BY-LAW NO. 4, 1967".

2. For highway purposes and for the construction and installation thereon of necessary municipal works and services, The Corporation of the District of Burnaby is hereby authorized and empowered, without the consent of the owners of the real property, but subject to the provisions of Division (4) of Part XII of the Municipal Act: -

(a) By its servants and agents to enter upon, expropriate, break up, take or enter into possession of or use all and singular that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as follows:

(i) The North Twenty (20') feet of the West Half of Block Thirty-One (31), Lot Thirty-Five (35), Group 1, Plan 799, Except the East Sixty (60') feet thereof, New Westminster District, as shown outlined red on plan attached hereto.

(ii) The North Twenty (20') feet of the East Sixty (60') feet of the West Half of Block Thirty-One (31), Lot Thirty-Five (35), Group 1, Plan 799, New Westminster District, as

shown outlined red on plan attached hereto;

(iii) The North Twenty (20') feet of the East Sixty-two (62') feet of Block Three (3), of Lot Thirty-Five (35), Group One (1), Plan 799, New Westminster District, as shown outlined red on plan attached hereto;

(iv) A portion of the East One-Half of Block Thirty-One (31), Lot Thirty-Five (35), Plan 799, Group One (1), New Westminster District, more particularly described as follows:

Commencing at the South East corner of Lot "D", Plan 18172,

Thence, S. 2° 34' 10" W., 20 feet;

Thence, N. 87° 29' 25" W., 68.84 feet;

Thence, N. 2° 34' 10" E., 20 feet;

Thence, S. 87° 29' 25" E., 68.84 feet, more or less to the point of commencement and containing 1377 square feet,

all of which are shown outlined red on Reference Plan prepared by G. C. Emerson, B.C.L.S., dated the 8th day of June, 1967 and filed in the Land Registry Office at New Westminster under number 31314.

(b) By its servants and agents to enter upon any real property which may be injuriously affected by the exercise of any of the aforesaid powers for the purpose of executing any works of construction, maintenance or repair in mitigation of injuries done or apprehended or in reduction of compensation.

3. This by-law shall, before coming into effect, be published once in the B. C. Gazette and in a newspaper published or circulating in the Municipality of Burnaby and a certified copy of the by-law shall be filed in the Land Registry Office at the City of New Westminster, in the Province of British Columbia.

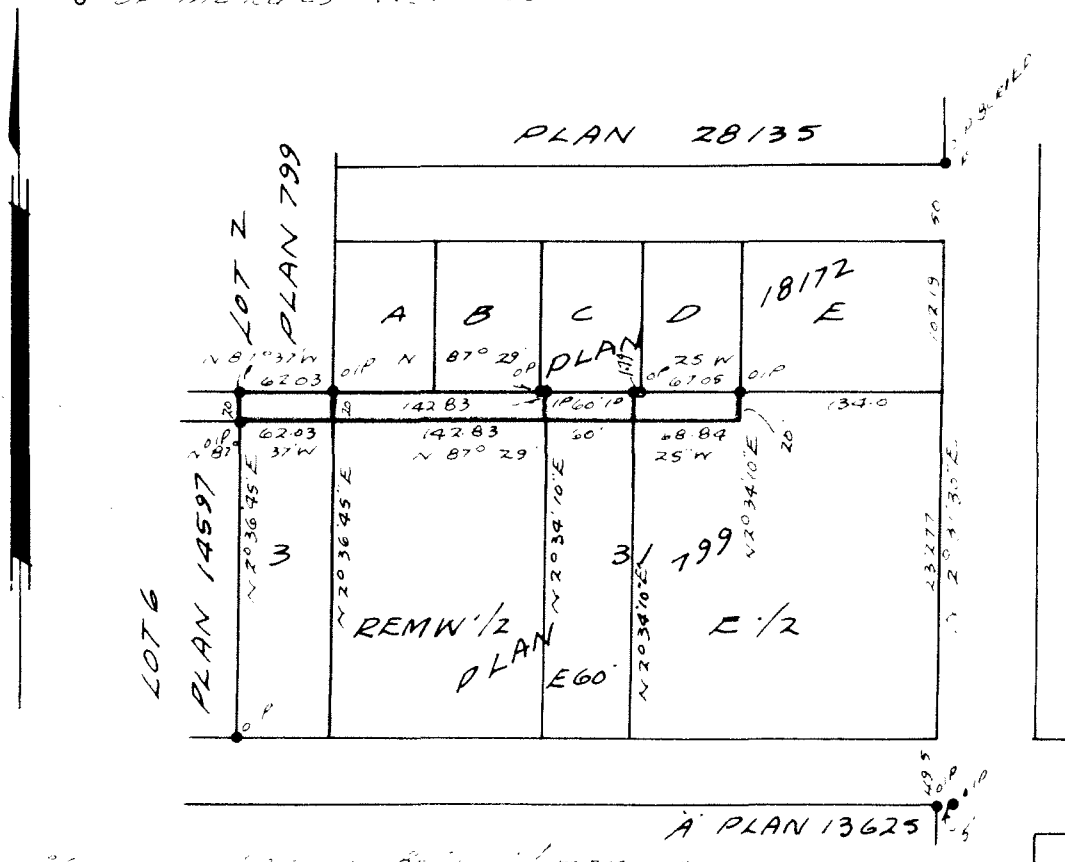
