

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5195

A BY-LAW to Stop Up and Close to Traffic
a Portion of Road.

WHEREAS that portion of road shown outlined red on plan annexed hereto was established as highway by those certain plans deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under number 31019 and 31569.

AND WHEREAS the said portion of road is no longer required for highway purposes.

1. This By-law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 7, 1967".
2. That portion of road (hereinafter called "the said portion"), being all and singular that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as a portion of District Lot Ten (10), Plans 31019 and 31569, Group One (1), New Westminster District, which said portion is more particularly described as follows:

Commencing at the southeast corner of Lot 64 according to said Plan 31569;

Thence N. 89° 34' 55" W., along the southerly boundary of said Lot 64, 530.53 feet, more or less, to a point of curve therein;

Thence westerly, northwesterly and northerly, along the southwest boundary of said Lot 64, being along the arc of a simple curve to the right of radius 35.00 feet, 59.99 feet, more or less, to a point of curve therein;

Thence southerly and southwesterly and following the production southerly and southwesterly of the west boundary of said Lot 64, being along the arc of a simple curve to the right of radius 700.62 feet, 133.50 feet, more or less, to a point of curve in the northwest boundary of Lot 63 according to aforesaid Plan 31569;

Thence northeasterly and easterly, along the northwest boundary of said Lot 63, being along a simple curve to the right of radius 35.00 feet, 43.30 feet, more or less, to a point of tangency therein;

Thence S. 89° 34' 55" E., along the north boundary of said Lot 63, 554.32 feet, more or less, to an angle therein;

Thence N. 8° 25' 00" E., along the west boundary of said Lot 63, 66.65 feet, more or less, to the point of commencement, and containing by calculation, 0.883 acres, be the same, more or less, as shown outlined in red on the Plan prepared by Donald S. Black, B.C.L.S., dated the 8th day of August, 1967, a copy of which is hereunto annexed;

is hereby stopped up and closed to traffic.

3. The Reeve and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portion and vest title thereto in The Corporation of the District of Burnaby.
