

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5198

A BY-LAW to Stop Up and Close to Traffic
a Portion of Road.

WHEREAS that portion of road shown outlined red on plan annexed hereto was established as highway by that certain plan deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under number 15274.

AND WHEREAS the said portion of road is no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 8, 1967".

2. That portion of road (hereinafter called "the said portion"), being all and singular that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as a portion of District Lot Two Hundred and Seven (207), Group One (1), Plan 15274, New Westminster District, which said portion is more particularly described as follows:

Commencing at the Southwesterly corner of Lot "F" of Lot 29 of Block 5 of the said District Lot 207, according to plan 15274, deposited;

Thence S.87° 51' 30" E. and following the Southerly boundary of Lot "F", aforesaid, 93.70 feet, more or less, to the Southeasterly corner thereof;

Thence South and following the Southwardly production of the Easterly boundary of the said Lot "F", 33.02 feet, more or less, to the Southerly limit of Road, as shown on plan 15274, aforesaid;

Thence N.87° 51' 30" W., following parallel to, and 33.00 feet perpendicularly distant from the said Southerly boundary of Lot "F", 93.74 feet, more or less, to the most Southwesterly corner of dedicated Road, according to the said plan 15274;

Thence N. 0° 05' 00" E. and following the Southwardly production of the Westerly boundary of the said Lot "F", being also the most Westerly limit of the said dedicated Road, 33.02 feet, more or less, to the point of commencement and containing, by calculation, 0.071 of an acre, be the same, more or less, as shown outlined in Red Colour on the Plan prepared by Gordon M. Thomson, B.C.L.S., dated the 24th day of August, 1967, a copy of which is annexed hereto;

is hereby stopped up and closed to traffic.

3. The Reeve and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portion and vest title thereto in The Corporation of the District of Burnaby.
