

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5392

A BY-LAW to authorize the expropriation of certain real property.

WHEREAS it is deemed necessary and in the public interest to expropriate the real property hereinafter described for highway purposes and to construct and install therein and thereon necessary municipal works and services.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY HIGHWAY EXPROPRIATION BY-LAW NO. 7, 1968".
2. For highway purposes and for the construction and installation therein and thereon of necessary municipal works and services, The Corporation of the District of Burnaby is hereby authorized, empowered, without the consent of the owners of the real property, but subject to the provisions of Division (4) of Part XII of the "Municipal Act":

(a) By its servants and agents to enter upon, expropriate, break up, take or enter into possession of or use all and singular those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly described as follows:

(i) The Easterly Thirty-Four (34') feet of Lots Two (2), and Three (3), Block Three (3), Lot Six (6), Group One (1), Plan 14139, New Westminster District;

(ii) The Easterly Thirty-Four (34') feet of Lot One (1), Block Three (3), Lot Six (6), Group One (1), Plan 14139, New Westminster District;

(iii) The Easterly Thirty-Four (34') feet of Lot One (1) of Parcel "A", the South Half of Lot Eight (8), Group One (1), Plan 11217, New Westminster District, Except West Seventy-One (71') feet thereof;

(iv) The Easterly Thirty-Four (34') feet of Lot Two (2) of Parcel "A" of the South Half of Lot Eight (8), Group One (1), Plan 11217, New Westminster District;

(v) The Easterly Thirty-Four (34') feet of the East One Hundred Sixty-One (161') feet of Parcel Eight (8) (Explanatory Plan

12935) of Parcel Six (6) of Parcel "A" of South Half of Lot Eight (8), Group One (1), New Westminster District;

(vi) The Easterly Thirty-four (34') feet of the East One Hundred Sixty-One (161') feet of Parcel Seven (7) (Explanatory Plan 12734) of Parcel "A" of South Half of Lot Eight (8), Group One (1), New Westminster District;

(vii) The Easterly Thirty-Four (34') feet of Part 66' by 132' of Lot Eight (8), Group One (1), Map 1628, New Westminster District;

(viii) The Easterly Thirty-Four (34') feet of Part 132' by 132' of Lot Eight (8), Group One (1), as shown outlined in red on sketch 1724, New Westminster District;

(ix) All that part of Lot Three (3), Block Two (2), of Lot Eight (8), Group One (1), Plan 11539, New Westminster District, which may be more particularly described as follows:

Commencing at the South East corner of the said Lot Three (3);

Thence S.  $89^{\circ} 17' 50''$  W. and following the South boundary of the said Lot Three (3), for 34.01 feet;

Thence N.  $6^{\circ} 42' 30''$  E. for 215.28 feet more or less to the North East corner of the said Lot Three (3);

Thence S.  $2^{\circ} 22' 40''$  E. and following the East boundary of the said Lot Three (3) for 213.57 feet more or less to the point of commencement;

the said part containing 0.083 acres more or less;

all of the above shown outlined in red colour on reference plan prepared by J. E. Rattenberry, B.C.L.S., dated the 17th day of September, 1968, a copy of which is hereunto annexed.

2. (b) By its servants and agents to enter upon any real property which may be injuriously affected by the exercise of any of the aforesaid powers for the purpose of executing any works of construction, maintenance or repair in mitigation of injuries done or apprehended or in reduction of compensation.

3. This By-law shall, before coming into effect, be published once in the B. C. Gazette and in a newspaper published or circulating in the Municipality of Burnaby and a certified copy of the by-law shall be filed in the Land Registry Office at New Westminster,

in the Province of British Columbia.
