THE CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 5468

A BY-LAW to Stop Up and Close to Traffic a portion of road.

WHEREAS that portion of road shown outlined in red on Plan annexed hereto was established as highway by that certain plan deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under number 1869.

AND WHEREAS the said portion of road is no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This By-Law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 1, 1969".
- 2. That portion of road (hereinafter called the "said portion"), being all and singular that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as a portion, formerly road, of District Lot Ninety-one (91), Group One (1), Plan 1869, New Westminster District, and which said portion is more particularly described as follows:

Commencing at the most Southerly corner of Lot 169, Plan 24948, deposited:

Thence N. 40°10' 00" W. and following a portion of the Southwesterly boundary of said Lot 169, 413.14 feet, more or less, to the most Easterly corner of Parcel "S", Explanatory Plan 34164, deposited;

Thence N. 73° 13' 30" W. and following a portion of the Southwesterly boundary of Parcel "S", aforesaid, 120.99 feet, more or less, to an intersection with the Northeasterly boundary of Lot "C", Plan 3243, deposited;

Thence S. 40° 10' 00" E. and following the North-easterly boundary of said Lot "C", 514.57 feet, more or less, to the most Easterly corner thereof;

Thence N. 49° 50' 00"E., 66.00 feet, more or less, to the point of commencement;

And containing, by calculation, 0.703 of an acre, be the same, more or less, as shown outlined in red on plan hereunto annexed prepared by L.T. Schwendtmayer, B.C.L.S., dated the 20th day of December, 1968.

is hereby stopped up and closed to traffic.

3. The Mayor and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portion and vest title thereto in The Corporation of the District of Burnaby.


