

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5672

A BY-LAW to stop up and close to traffic a portion of road.

WHEREAS that portion of road shown outlined in red on Plan annexed hereto was established as highway by that certain plan deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under number 1165.

AND WHEREAS the said portion of road is no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 1, 1970".
2. That portion of road (hereinafter called the "said portion") being all and singular that certain parcel or tract of land and premises, situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as All and Singular that certain piece, parcel or tract of land and premises situate, lying and being in District Lot One Hundred Eighty-Eight (188), Group One (1), New Westminster District, being road known as Eton Street, and which may be described more particularly as follows:

Commencing at the northwest corner of Lot 28, Block 9, Plan 1165;

Thence N. $0^{\circ} 59' 30''$ W., and following the easterly boundary of Beta Avenue a distance of 66 feet, more or less, to the southwesterly corner of Lot 3, Plan 15301;

Thence N. $89^{\circ} 17' 55''$ E. and following the southerly boundary of said Lot 3, Plan 15301, a distance of 147.36 feet;

Thence southwesterly and following a circular curve to the right of radius 20 feet, an arc distance of 3.53 feet, to a point of reverse curvature;

Thence on a circular curve to the left of radius 45 feet, an arc distance of 76.61 feet, more or less to a point in the southerly boundary of Eton Street;

Thence S. 89° 17' 55" W., and following the southerly boundary of Eton Street, a distance of 122.87 feet, more or less, to the point of commencement.

Bearings used herein are astronomic and are referred to the meridian of Plan 14775 deposited.

The herein-described parcel contains by calculation 0.187 acre, be the same more or less, as shown outlined in red on Reference Plan certified correct by Bryan S. Berting, B.C.L.S., on the 11th day of February, 1970, a copy of which is annexed hereto,

is hereby stopped up and closed to traffic.

3. The Mayor and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portion and vest title thereto in The Corporation of the District of Burnaby.
