THE CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 5673 A BY-LAW to Stop Up and Close to Traffic a Portion of Road.

WHEREAS that portion of road shown outlined in red on Plan annexed hereto was established as highway by that certain plan deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under number 290.

AND WHEREAS the said portion of road is no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

This By-Law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 2, 1970".

2. That portion of road (hereinafter called the "said portion"), being all and singular that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being a portion, formerly road, of District Lot Sixty-nine (69), Group One (1), Plan 290, New Westminster District, which said portion is more particularly described as follows:

Commencing at the Southeasterly corner of the South 16.5 feet of Lot 5, of Block 21, according to Plan 1321, deposited;

Thence N. 0° 12' 00" E. and following the Easterly boundary of said South 16.5 feet of Lot 5, 16.5 feet more or less, to the Northeasterly corner thereof, said Northeasterly corner lying on a Southerly boundary of Lot "E", according to Explanatory Plan 29572, deposited;

Thence S. 89° 08'00" E. and following a Southerly boundary of Lot "E", aforesaid, 33.00 feet, more or less, to an angle corner thereof, said angle corner lying on the Westerly boundary of Lot "B", according to Plan 23177 deposited;

Thence S. 0° 12' 00" W. and following a portion of the Westerly boundary of said Lot "B", 16.5 feet, more or less, to the Southwesterly corner thereof;

Thence N. 89° 08' 00" W. and parallel to a Southerly boundary of Lot "E" aforesaid, 33.00 feet, more or less, to the point of commencement and containing by calculation

545 square feet, be the same, more or less, as shown outlined in red colour on the Plan prepared by Donald S. Black, B.C.L.S. dated the 27th day of February, 1970 a copy of which is attached hereto,

is hereby stopped up and closed to traffic.

3. The Mayor and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portion and vest title thereto in Lake-City Industrial Corporation Ltd.
