

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5729

A BY-LAW to authorize the construction of certain local improvement works.

WHEREAS the Council has received a petition to construct as a local improvement the works hereinafter described and the Municipal Clerk has certified that the said petition is sufficient.

AND WHEREAS it is expedient to grant the prayer of the said petition in the manner hereinafter provided.

AND WHEREAS Council has had prepared the report required by Section 601 of the Municipal Act.

AND WHEREAS the lifetime of the said works is twenty years.

AND WHEREAS the estimated cost of the said works is \$1,400.00.

AND WHEREAS the share or portion of the cost of the said works which should be borne by the parcels of land which abut or are deemed to abut on the said works is \$574.20.

AND WHEREAS the Corporation's share or proportion of the cost of the said works is \$825.80.

AND WHEREAS the special charges should be made payable in ten annual instalments.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY LOCAL IMPROVEMENT CONSTRUCTION BY-LAW NO. 21, 1970".
2. The Council of The Corporation of the District of Burnaby is hereby authorized and empowered to construct as a local improvement, under the provisions of Part XVI of the Municipal Act, on Moreland Street from Gatenby Avenue to western boundary Lots 172 and 173, D.L. 80, Plan 33614, and Monarch Street from Gatenby Avenue to

western boundary Lots 164 and 165, D.L. 80, Plan 33614, all necessary equipment, wires and works, including standards and underground conduits, for the purpose of supplying public lighting for the said streets.

3. The Mayor and Clerk are authorized and empowered to cause a contract for the construction of the said works to be made and entered into with some person or persons, firm or corporation, subject to the approval of Council to be declared by resolution.

4. The special charges shall be paid by ten annual instalments.

5, The Council may, with the approval of the Inspector of Municipalities, borrow temporarily the sum required to finance the cost of the said works pending the adoption of a by-law under Section 603.
