

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5734

A BY-LAW to Stop Up and Close to Traffic a
Portion of Road.

WHEREAS that portion of road shown outlined in red on Plan annexed hereto was established as highway by that certain plan deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under number 2043.

AND WHEREAS the said portion of road is no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 9, 1970".
2. That portion of road (hereinafter called the "said portion"), being all and singular that certain parcel or tract of land and premises, situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as All and Singular that certain part, parcel or tract of land and premises situate, lying and being a portion of Block Nineteen (19), District Lot One Hundred Fifty-Nine (159), Group One (1), District of New Westminster, Province of British Columbia, according to Plan 2043 deposited, and being known and more particularly described as follows:

Commencing at the Southwest corner of Lot 8 of Blocks 11, 16 and 19 of District Lot 159, Group 1, New Westminster District, according to Plan 2043 deposited;

Thence N.14°19'52"W. and following the Westerly boundary of said Lot 8, 126.45 feet more or less, to the Northwesterly corner thereof;

Thence N.88°43'43"W. and following the Westerly production of the Northerly boundary of Lot 8 aforesaid, 20.76 feet more or less, to an intersection with the Easterly boundary of Lot "B" of Lots 1 and 9, Block 19 of District Lot 159, Group 1, New Westminster District; according to Plan 11493 deposited;

Thence S.14°19'52" E. and following a portion of the Easterly boundary of Lot "B" aforesaid, 126.47 feet more or less, to an intersection with the Westerly production of the Southerly boundary of Lot 8 aforesaid;

Thence S.88°47'15" E. and following the said Westerly production of the Southerly boundary of Lot 8 aforesaid, 20.76 feet more or less, to the point of commencement and containing by admeasurement 0.058 of an acre more or less, as shown outlined in red on reference plan prepared by Ronald G. Scobbie, B.C.L.S., and sworn the 26th day of May, 1970, a copy of which is annexed hereto,

is hereby stopped up and closed to traffic.

3. The Mayor and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portion and vest title thereto in William John Didier and Valerie Gaye Mary Didier, Joint Tenants.
