

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 5861

A BY-LAW to authorize the borrowing of **\$415,000.00** under the terms of the Federal-Provincial Special Development Loan Program to finance the cost of constructing miscellaneous parks and recreation projects.

WHEREAS Council deems it desirable and in the public interest to improve and construct those public parks and recreation facilities more particularly described in an application dated the 11th day of March, 1971 submitted to the Department of Municipal Affairs by The Corporation of the District of Burnaby under the provisions of the Federal-Provincial Special Development Loan Program.

AND WHEREAS the estimated cost of improving and constructing the said facilities is \$415,000.00.

AND WHEREAS Council deems it desirable and in the public interest to borrow the said sum of \$415,000.00, which is the amount of the debt intended to be created by this by-law, under the terms of the Federal-Provincial Special Development Loan Program.

AND WHEREAS the amount of the assessed value for general municipal purposes of the taxable land and improvements of the Municipality for the year 1970 is \$803,067,890.00 and for the years 1969 and 1968 was respectively \$726,793,723.00 and \$640,141,431.00.

AND WHEREAS the depreciated value as at the 31st day of December, 1970 of the municipal waterworks system, for which the Municipality possesses a subsisting certificate of self-liquidation granted by the Inspector of Municipalities, was \$8,551,369.00.

AND WHEREAS the amount of the existing outstanding debenture debt of the Municipality is \$17,680,120.25, and the amount of the debenture debt of the Municipality authorized and unissued is \$1,000,000.00 and none of the principal and interest of the said debenture debt is in arrears.

AND WHEREAS the maximum term for which debentures may be issued is fifteen years.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY LOAN AUTHORIZATION BY-LAW NO. 3, 1971".

2. The Corporation of the District of Burnaby is hereby authorized and empowered to borrow the sum of \$415,000.00 under the provisions of the Federal-Provincial Special Development Loan Program to finance the cost of improving and constructing those public parks and recreation facilities more particularly described in an application dated the 11th day of March, 1971 submitted to the Department of Municipal Affairs by The Corporation of the District of Burnaby under the provisions of the Federal-Provincial Special Development Loan Program.
