## THE CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 5865 A BY-LAW TO Stop Up and Close to Traffic Portions of Road.

WHEREAS those portions of road shown outlined in red on plan attached hereto were established as highways by the British Columbia Gazette of October 17, 1918, page 2829 and by plan deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under number 1256.

AND WHEREAS the said portions of road are no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

This By-Law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 4, 1971".

2. Those portions of road (hereinafter called the "said portions"), being all and singular those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly described in Schedule "A" attached hereto, and shown outlined in red on plan attached hereto, are hereby stopped up and closed to traffic.

3. The Mayor and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portions and vest title thereto in The Corporation of the District of Burnaby.
