The Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD ACQUISITION AND DEDICATION BY-LAW NO. 2, 1971".

2. The Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from the registered owner thereof by a good and sufficient deed in fee simple, free and clear of all encumbrances, for highway purposes, in consideration of the sum of One (\$1.00) Dollar and other good and valuable consideration, those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as a portion of Parcel "A" (Reference Plan 12502) of Lot Two (2), Block "F" of District Lot One Hundred Eighteen (118), Group One (1), Plan 3067, New Westminster District, which said portion is more particularly described in Schedule "A" attached hereto.


