## THE CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 5950

A BY-LAW to Stop Up and Close to Traffic a Portion of Road.

WHEREAS that portion of road shown outlined in red on plan annexed hereto was established as highway by that certain plan deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under Plan Number 4417.

AND WHEREAS the said portion of road is no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This By-law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 11, 1971".
- 2. That portion of road being all and singular that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, being all that portion of District Lot One Hundred Thirty-Six (136), Group One (1), New Westminster District, according to the Plan deposited in the Land Registry Office at New Westminster, Province of British Columbia, and numbered 4417, which said portion is more particularly described as follows:

Commencing at the north-east corner of Parcel "A" Explanatory Plan 13838, of Lot 20, Plan 11768 of said District Lot 136, Group 1, thence south 131.09 feet;

The nce on a circular curve to the east of radius 45.00 feet and tangential to a line bearing N.42°49'47" E an arc distance of 37.05 feet;

Thence north and following the easterly boundary of said District Lot 136, 117.04 feet;

Thence S.89°32' W, 33.00 feet more or less to the point of commencement and containing 0.0919 of an acre more or less as shown on the plan hereto attached and outlined red;

is hereby stopped up and closed to traffic.

The Mayor and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portion and vest title thereto in The Corporation of the District of Burnaby.
