BY-LAW NO. 5973

A BY-LAW To Stop Up and Close to Traffic
Portions of Lane

WHEREAS those portions of lane shown outlined in red on plan annexed hereto were established as lane by those certain plans deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under number 3485.

AND WHEREAS the said portions of lane are no longer required for lane purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-Law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 13, 1971".
2. That portion of lane (hereinafter called the "said portion "A"") being all and singular that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being lane dedicated by Plan 3485 deposited, comprising part of District Lot Ninety-seven (97), Group One (1), New Westminster District, which said portion is more particularly described in Schedule "A" attached hereto, is hereby stopped up and closed to traffic.
3. The Mayor and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portion "A" and vest title thereto in The Corporation of the District of Burnaby.

SCHEDULE "A"

All and singular that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, Province of British Columbia, being lane dedicated by Plan 3485 deposited, comprising part of District Lot 97, Group 1, New Westminster District, and which may be described more particularly as bounded as follows:

Commencing at the southwest corner of Lot 12, Block 11, Plan 2802;

thence S 89° 15' 00" E, and following the south boundary of the said Lot 12, a distance of 109.00 feet, more or less, to the southeast corner thereof;

thence S 0° 33' 00" W, and following the straight line joining the southeast corner of the said Lot 12, Block 11, to the northeast corner of Lot 12, Block 19A, Plan 8134;

thence N 89° 15' 00" W, and following the north boundary of the last-mentioned Lot 12, a distance of 109.00 feet, more or less, to the northwest corner thereof;

thence N 0° 33' 00" E, and following the straight line joining the northwest corner of the said Lot 12, Block 19A, to the point of commencement, a distance of 20.00 feet, more or less.

The herein-described parcel contains by calculation 2180 square feet, more or less.
