## BY-LAW NO. 6091

A BY-LAW to authorize the expenditure of \$206,574.81 from the reserve fund set aside under the provisions of Section 304 of the Municipal Act.

WHEREAS the Council has set aside in a reserve fund all moneys received from the sale of tax-sale properties.

AND WHEREAS the said reserve fund may be used to finance capital expenditures or expenditures of a special nature.

AND WHEREAS sinking funds on hand are equal to or greater than requirements.

AND WHEREAS there was on deposit in the said reserve fund on the 26th day of March, 1972 the sum of \$2,888,852.61.

AND WHEREAS the Council deems it desirable and in the public interest to expend the sum of \$206,574.81 from the said reserve fund for the purpose hereinafter specified.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY TAX-SALE MONEYS EXPENDITURE BY-LAW NO. 2, 1972".

2. The Council is hereby authorized and empowered to expend the sum of \$206,574.81 from the said reserve fund to repay the moneys expended from general revenue for the acquisition of those lands required for municipal purposes more particularly described in Schedule "A" annexed hereto.
