BY-LAW NO. 6131

A BY-LAW to Stop Up and Close to Traffic  
Portions of Road

WHEREAS those portions of road shown outlined in red on plan annexed hereto were established as road by those certain plans deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under No. 3051.

AND WHEREAS the said portions of road are no longer required for road purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-Law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 8, 1972".
2. Those portions of road being all and singular those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia and being a portion of District Lot Seventy-seven (77), Plan 3051, New Westminster District, which said portions are more particularly described in Schedule "A" attached hereto, are hereby stopped up and closed to traffic.
3. The Mayor and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portions and vest title thereto in the name of The Corporation of the District of Burnaby.





SCHEDULE "A"

All that part of Hardwick Street and all that portion of Woodsworth Street lying and being within Block 4, District Lot 77, Group 1, Plan 3051, N.W.D., in the Municipality of Burnaby, Province of British Columbia, and which said part and portion may be more particularly described as follows:

**Firstly:** All that part of Hardwick Street having a full width of 66 feet and bounded easterly by a straight line joining the southeast corner of Lot 35 to the northeast corner of Lot 70; and bounded westerly by a northerly production of the westerly boundary of Lot 57; the said part containing 0.700 acres more or less.

**Secondly:** All that portion of Woodsworth Street having a full width of 66 feet and bounded easterly by a straight line joining the southeast corner of Lot 87 to the northeast corner of Lot 122, and bounded westerly by a straight line joining the southwest corner of Lot 100 to the northwest corner of Lot 109; the said portion containing 0.700 acres more or less.

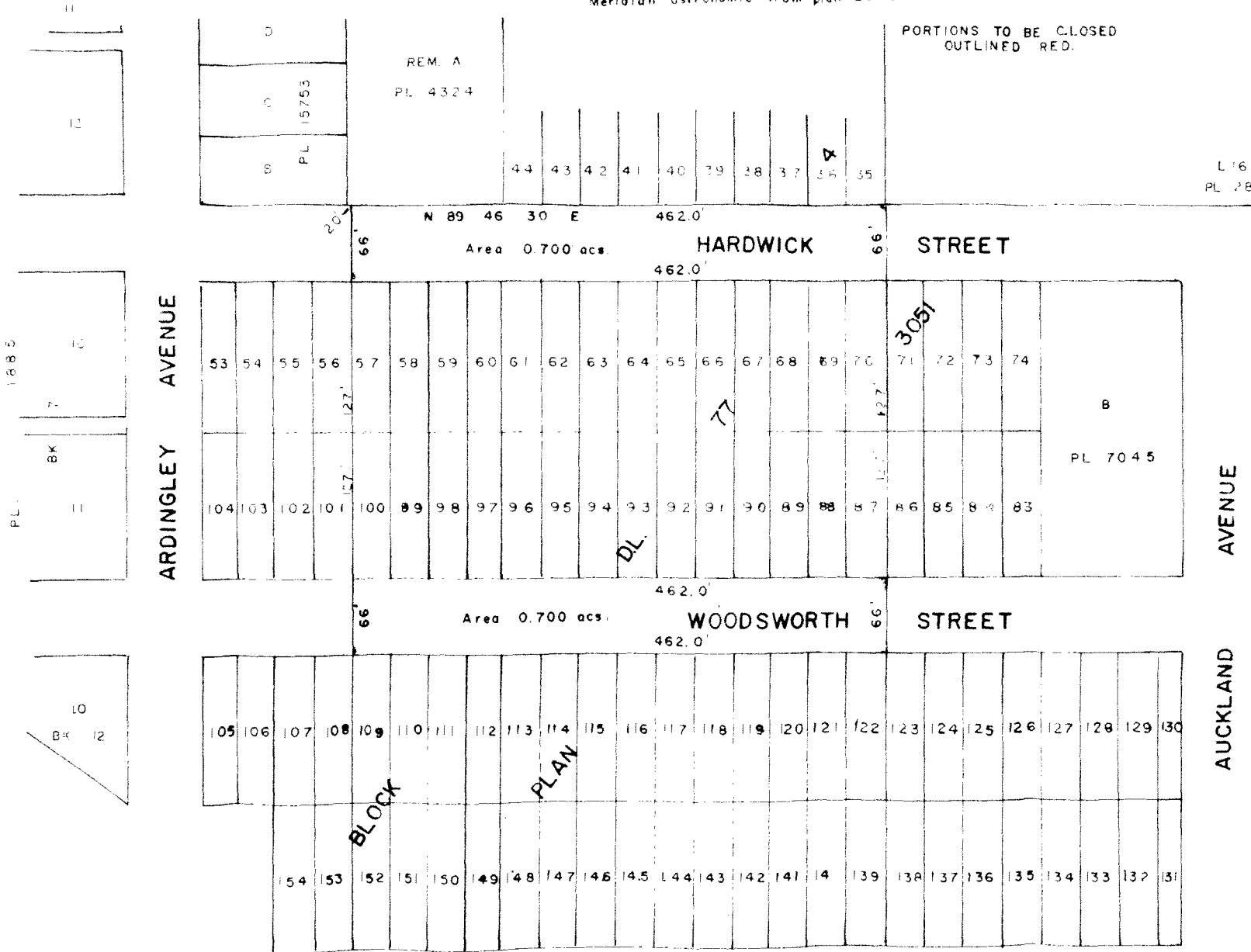
