A BY-LAW to amend By-Law No. 4742, being "Burnaby Zoning By-Law 1965"

- The Map (hereinafter called "Map "A"") attached to and forming an integral part of By-Law No. 4742, being "Burnaby Zoning By-Law 1965", and designated as the Official Zoning Map of The Corporation of the District of Burnaby, is hereby amended according to the Map (hereinafter called "Map "B""), marginally numbered R.Z. 494, annexed to this By-Law, and in accordance with the explanatory legend, notations, references and boundaries designated, desribed, delimited and specified in particularity shown upon said Map "B"; and the various boundaries and districts shown upon said Map "B" respectively are in amendment of and in substitution for the respective districts, designated nd marked on said Map "A" insofar as the same are changed, modified or varied hereby, and the said Map "A" shall be deemed to be and is hereby declared to e amended accordingly and the said Map "B" is hereby declared to be and shall orm an integral part of said Map "A", as if originally incorporated therein, nd shall be interpreted accordingly.




