BY-LAW NO. 6256

A BY-LAW to Stop Up and Close to Traffic
Portions of Road

WHEREAS those portions of road shown outlined in red on plan annexed hereto were established as road by those certain plans deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, under No. 1292.

AND WHEREAS the said portions of road are no longer required for road purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 4, 1973".
2. Those portions of road being all and singular those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia and being a portion of District Lot One Hundred Fifty-Two (152), Group 1, Plan 1292, New Westminster District, which said portion may be more particularly known and described as that portion of District Lot One Hundred Fifty-Two (152), Plan 1292, shown outlined in red on By-law plan prepared by B. S. Berting, B.C.L.S., and dated the 30th day of January, 1973, copy of which is hereunto attached.
3. The Mayor and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portion and vest title thereto in the name of The Corporation of the District of Burnaby.

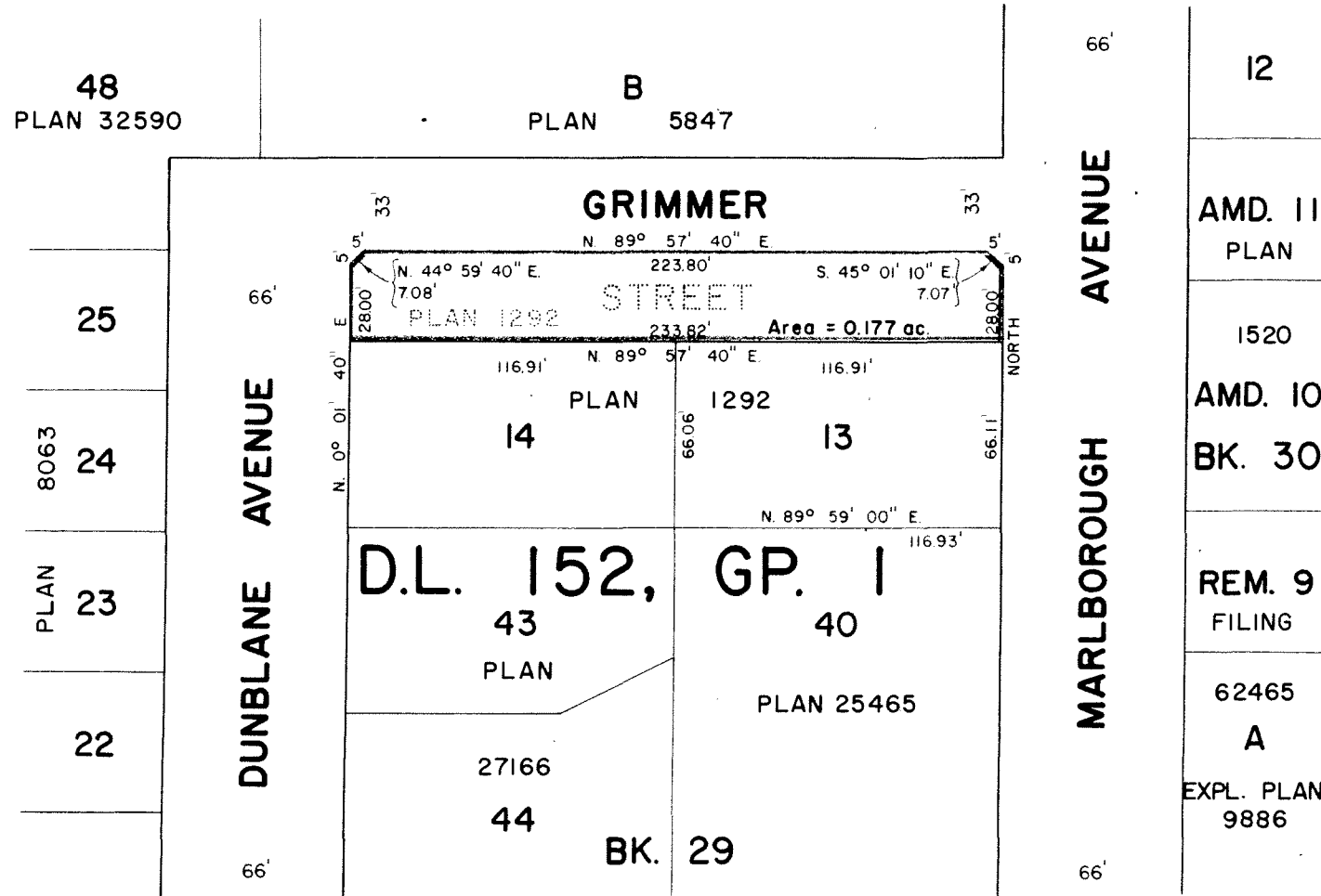
