## THE CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 6296

A BY-LAW to acquire certain lands for highway purposes.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-Law may be cited as "BURNABY ROAD ACQUISIT-ION AND DEDICATION BY-LAW NO. 3, 1973."

2. The Council of The Corporation of the District of Burnaby is hereby authorized and empowered to acquire from the registered owners thereof by a good and sufficient deed in fee simple, free and clear of all encumbrances, for highway purposes, in consideration of the sum of One (\$1.00) Dollar and other good and valuable consideration, those lands and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia:

- (1) Being that portion of the easterly half of the northerly half of Lot 34 of District Lot 28, Group 1, Plan 632, having a frontage of 36 feet on Edmonds Street by half the full depth of said Lot 34 and adjoining Lot 33, except the westerly three feet (Expl. Plan 13172), New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.
- (2) Being that portion of the southerly half of Lot 34 of Lot 28, Group 1, Plan 632, being all that portion of said Lot 34, lying south of a straight line bisecting the east and west boundaries thereof, New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached.
- (3) Being that portion of Parcel "A" (Expl. Plan 13172) of Lots 34 and 35 of District Lot 28, Plan 632, New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.

- (4) Being that portion of the southerly half of Lot 35 of the northerly portion of Lot 28, Group 1, Plan 632, being all that portion of said Lot 35 lying south of a straight line bisecting the easterly and westerly boundaries thereof, New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.
- (5) Being that portion of the northerly half of Lot 36 of District Lot 28, Group 1, Plan 632, being all that portion lying to the north of a straight line bisecting the easterly and westerly boundaries thereof, New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.
- (6) Being that portion of the easterly half of the southerly half of Lot 36 of the north part of District Lot 28, Group 1, Plan 632, said easterly half having a frontage of 36 feet on 19th Avenue by half the full depth of said Lot and adjoining Lot 35, New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.
- (7) Being that portion of the westerly half of the southerly half of Lot 36 of District Lot 28, Group 1, Plan 632, having a frontage of 36 feet on 19th Avenue by half of the full depth of said lot and adjoining Lot 37, New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.
- (8) Being that portion of the northerly half of Block 37 of the north portion of District Lot 28, Group 1, Plan 632, being all that portion of said Block 37 lying north of a straight line bisecting the easterly and westerly boundaries, New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.
- (9) Being that portion of the southerly half of Block 37 of the north portion of District Lot 28, Group 1, Plan 632, being all that portion of said Block 37, lying south of a straight line bisecting the easterly and westerly boundaries thereof, New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.

- (10) Being that portion of the northerly half of Lot 41 of the north half of Lot 28, Group 1, Plan 632, being all that portion of said Lot 41 lying to the north of a straight line bisecting the easterly and westerly boundaries thereof, New Westminster District, as shown outlined in red on By-Law Plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.
- (11) Being that portion of the southerly half of Lot 41 of District Lot 28, Group 1, Plan 632, being all that portion of said Lot 41 lying to the south of a straight line bisecting the east and west boundaries thereof, New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.
- (12) Being that portion of Block 42 of District Lot 28, Group 1, Plan 632 EXCEPT FIRSTLY: Part shown as Lane on Explanatory Plan 12641 and SECONDLY: Parcel "A" (Explanatory Plan 12641) AND the northerly halves of Blocks 43 and 44 of District Lot 28, Group 1, Plan 632, being all those portions lying north of a straight line bisecting the easterly and westerly boundaries thereof, New Westminster District, to which parcels of land the Registrar has assigned the distinguishing letters "A" and "B" respectively, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.
- (13) Being that portion of Block 43 of the north part of Lot 28, Group 1, Plan 632, being all that portion lying to the south of a straight line bisecting the easterly and westerly boundaries of said Block 43, New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16th day of April, 1973, a copy of which is attached hereto.
  - (14) Being that portion of Block 44 of District Lot 28, Group 1, Plan 632, being all that portion of said Block lying south of a straight line bisecting the easterly and westerly boundaries thereof, New Westminster District, as shown outlined in red on By-Law plan prepared by B.S. Berting, B.C.L.S. and sworn the 16 th day of April, 1973, a copy of which is attached hereto.

3. Upon registration of the said deedsin fee simple in the Land Registry Office at the City of New Westminster, in

the Province of British Columbia, the said lands shall be established as a public highway.
