THE CORPORATION OF THE DISTRICT OF BURNABY
BY-LAW NO. 6304

A BY-LAW to amend By-Law No. 6052, being the "Burnaby Noise or Sound Abatement By-Law 1972".

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This By-Law may be cited as "BURNABY NOISE OR SOUND ABATEMENT BY-LAW 1972, AMENDMENT BY-LAW NO. 1, 1973".
- 2. Section 9 of By-Law No. 6052 is repealed and the following substituted therefor:
  - Up to June 1, 1974 no person shall between 7:00 a.m. and 10:00 p.m., except as herein provided, in a Commercial District, Industrial District, Comprehensive Development District or Agricultural District in the Municipality make or cause continuous noise or continuous sound the noise or sound level of which exceeds 70 dBA's. When the continuous noise or continuous sound is emanating from real property in a Commercial District, Industrial District, Comprehensive Development District or Agricultural District the continuous noise or continuous sound shall be measured at any point on the property line or within 20 feet of the property line of the real property from which the said continuous noise or said continuous sound is emanating. When the continuous noise or continuous sound is emanating from a highway in a Commercial District, Industrial District, Comprehensive Development District or Agricultural District the continuous noise or continuous sound shall be measured at a distance of not less than 20 feet from the source of the said continuous noise or said continuous sound."

- 3. Section 10 of By-Law No. 6052 is repealed and the following substituted therefor:
  - Up to June 1, 1974 no person shall between 10:00 p.m. and 7:00 a.m., except as herein provided, in a Commercial District, Industrial District, Comprehensive Development District or Agricultural District in the Municipality make or cause continuous noise or continuous sound the noise or sound level of which exceeds 65 dBA's. When the continuous noise or continuous sound is emanating from real property in a Commercial District, Industrial District, Comprehensive Development District or Agricultural District the continuous noise or continuous sound shall be measured at any point on the property line or within 20 feet of the property line of the real property from which the said continuous noise or said continuous sound is eman-When the continuous noise or continuous sound ating. is emanating from a highway in a Commercial District, Industrial District, Comprehensive Development District or Agricultural District the continuous noise or continuous sound shall be measured at a distance of not less than 20 feet from the source of the said continuous noise or said continuous sound."
- 4. Section 11 of By-Law No. 6052 is repealed and the following substituted therefor:
  - "11. From June 2, 1974 to June 1, 1978 no person shall between 7:00 a.m. and 10:00 p.m., except as herein provided, in a Commercial District, Industrial District, Comprehensive Development District, or Agricultural District in the Municipality make or cause continuous noise or continuous sound the noise or sound level of

which exceeds 65 dBA's. When the continuous noise or continuous sound is emanating from real property in a Commercial District, Industrial District, Comprehensive Development District or Agricultural District the continuous noise or continuous sound shall be measured at any point on the property line or within 20 feet of the property line of the real property from which the said continuous noise or said continuous sound is emanating. When the continuous noise or continuous sound is emanating from a highway in a Commercial District, Industrial District, Comprehensive Development District or Agricultural District the continuous noise or continuous sound shall be measured at a distance of not less than 20 feet from the source of the said continuous noise or said continuous sound."

- 5. Section 12 of By-Law No. 6052 is repealed and the following substituted therefor:
  - 12. From June 2, 1974 to June 1, 1978 no person shall between 10:00 p.m. and 7:00 a.m., except as herein provided, in a Commercial District, Industrial District, Comprehensive Development District or Agricultural District in the Municipality make or cause continuous noise or continuous sound the noise or sound level of which exceeds 60 dBA's. When the continuous noise or continuous sound is emanating from real property in a Commercial District, Industrial District, Comprehensive Development District or Agricultural District the continuous noise or continuous sound shall be measured at any point on the property line or within 20 feet of the property line of the real property from which the said continuous noise or said continuous sound is emanating.

When the continuous noise or continuous sound is emanating from a highway in a Commercial District, Industrial District, Comprehensive Development District or Agricultural District the continuous noise or continuous sound shall be measured at a distance of not less than 20 feet from the source of the said continuous noise or said continuous sound."
