THE CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 6346

A BY-LAW to amend By-Law No. 3970, being the "Burnaby Shops Closing By-Law 1958".

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This By-law may be cited as "BURNABY SHOPS CLOSING BY-LAW 1958, AMENDMENT BY-LAW 1973".
- 2. Section 3 of By-Law No. 3970 is repealed and the following substituted therefor:
- "3. For the local convenience and well-being of the residents of the Municipality, the Council does hereby
- (a) exempt completely from the provisions of sections 858 and 859 of the Municipal Act the classes of shops more particularly defined in section 2 of this by-law, and
- (b) exempt completely during the month of December in each year from the provisions of section 859 of the Municipal Act and from the provisions of any by-law adopted thereunder, the defined classes of shops more particularly set out in Schedule "A" hereof."

Read a first time this 1st day of October, 1973. Read a second time this day of 1973. 1st October, 1973. Read a third time this day of October, lst Reconsidered and adopted this day of October 9th

SCHEDULE "A"

Class of Shop

1. Agricultural Machinery and Machine Parts Shop

"Agricultural Machinery and Machine Parts Shop" means a shop where the principal or only trade or business is the sale by retail of agricultural machinery and machine parts.

2. Automobile Dealer

"Automobile Dealer" means a shop where the principal or only trade or business is the sale by retail of one or more of the following lines of products:

- (i) New Automobiles, including trucks;(ii) Used Automobiles, including trucks;
- (iii) Motor cycles;

(iv) Trailers;

- (v) Parts for automobiles, trucks, motor cycles and Trailers.
- Automobile Parts Shop

 "Automobile Parts Shop" means a shop where the principal or only trade or business is the sale by retail of new and used parts for automobiles, trucks, motor cycles and trailers.
- Bicycle Shoos
 "Bicycle Shop" means a shop where the principal
 or only trade or business carried on is the sale
 by retail of bicycles and parts therefor or the
 renting of bicycles.
- Boat Sales Shop
 "Boat Sales Shop" means a shop where the principal
 or only trade or business is the sale by retail
 of boats including motors, sails and other
 nautical equipment and supplies.
- Book Shops
 "Book Shops" means a shop where the principal or only trade or business is the sale by retail of books and magazines or either of them.
- 7. Builders' Supoly Houses
 "Builders' Supply House" means a shop where the principal or only trade or business carried on is the sale by retail of builders' supplies including lumber, hardware, bricks, cement, sand, gravel and miscellaneous items to be used in the construction, repair or alteration of buildings and associated structures.
- 8. Candy Shop
 "Candy Shop" means a shop where the principal or
 only trade or business carried on is the sale by
 retail of candies, nuts and gift cards.

- Clothing Shop" means a shop where the principal by retail of one or more of the following lines of goods: or only trade or business carried on is the sale
 - (i) Men's clothing; Ladies' clothing; (ii) (iii) Children's clothing; (iv) Shoes.
- <u>Customer Operated Dry Cleaning Establishment</u>
 "Customer Operated Dry Cleaning Establishment" 10A. means a shop where the principal or only trade or business is the sale by retail of the right by members of the general public to clean textiles, fabrics, garments and other articles by use of a dry cleaning machine utilizing a solvent other than water.
- Customer Operated Laundry means a shop where the iOB. principal or only trade or business is the sale by retail of the right by members of the general public to clean textiles, fabrics, garments and other articles by use of a laundry machine utilizing water as a solvent.
- Department Store means a shop composed of 11. five or more separately functioning departments in which retail trade or business of one or more of the classes defined in this Schedule is carried on in any one or more of such departments; but, nevertheless, "Department Store" shall not include any retail trade or business of the following classifications:
 - Barber Shops, (ii) Automobile Service Station, and (iii) Automobile Service Garage.
- 12. Delicatessen Shop "Delicatessen Shop" means a shop where the principal or only trade or business carried on is the sale by retail of prepared foods including cooked meats, pickles and relishes.
- 13. Drapery Shop "Drapery Shop" means a shop where the principal or only trade or business carried on is the sale by retail of draperies and curtains.
- 14. Dry.Cleaner and Laundry
 "Dry Cleaner and Laundry" means a shop where the principal or only trade or business carried on is one or more of the following services rendered directly to the general public:
 - Dry Cleaning of textiles, fabrics, garments and other articles; Laundering of textiles, fabrics, garments
 - (ii) and other articles.

- 15. Drug Stor€ "Drug Store" means a shop operated in conjunction with a Pharmacy having a registered Pharmacist in attendance for at least a portion of the days on which such shop is open for business and where the principal or only trade or business, apart from the dispensing of prescribed drugs, is the sale by retail of one or more of the following lines of goods:
 - Proprietary drugs;
 - (ii) Smokers' supplies;
 - (iii) (iy) Cosmetics;
 - Magazines;
 - (v) Stationery and school supplies;
 (vi) Candies and soft drinks;
 (vii) Toys;

 - (viii) Notions.
- <u>Electric Appliance and Supplies Shop</u>
 "Electric Appliance and Supplies Shop" means a 16. shop where the principal or only trade or business carried on is the sale by retail of one or more of the following lines of goods.
 - electric appliances including radios and television sets;
 - (ii) electrical supplies;
 - (iii) electric equipment.
- Engine Sales Shop" means a shop where the principal 17. or only trade or business carried on is the sale by retail of engines and parts therefor.
- Fabric Shop
 "Fabric Shop" means a shop where the principal or only trade or business carried on is the sale by retail of fabrics. 18.
- Feed Store means a shop where the principal 19. or only trade or business carried on is the sale by retail of feed, including hay, straw, grain, flour and fertilizer.
- 20. Fur Shoo" means a shop where the principal or only trade or business carried on is the sale by retail of furs or items manufactures from furs.
- Furniture Store means a shop where the principal 21. or only trade or business carried on is the sale by retail of new or used home furnishings, including furniture, carpets, carpeting and electrical appliances.
- Gift Shop
 "Gift Shop" means a shop where the principal or only trade or business carried on is the sale 22. by retail of a variety of arts and craft objects

 and bric-a-brac suitable as gifts.
- Grocery Shoo
 "Grocery Shop" means a shop where the principal
 or only trade or business carried on is the sale
 by retail of food-stuffs, including sugar, spices,
 coffee, fruits, and other commodities, chiefly
 edible.
- 24. Glass and Mirror Shop
 "Glass and Mirror Shop" means a shop where the principal or only trade or business carried on is the sale by retail of glass and mirrors.
- 25. Hairdressers' shops
 "Hairdressers' Shop" means a shop where the principal or only trade or business carried on is that of a hairdresser as defined in the "Hairdressers Act", Revised Statutes of British Columbia, 1960, Chapter 169.
- Hardware Store "Hardware Store" means a shop where the principal or only trade or business carriæd on is the sale by retail of hardware, including garden implements, electrical supplies, glass, crockery, stoves, paint and paint brushes.
- Heavy Construction Equipment Store
 "Heavy Construction Equipment Store" means a shop
 where the principal or only trade or business
 carried on is the sale by retail of heavy construction machines and aquipment.
- 28. Hobby Shop
 "Hobby Shop" means a shop where the principal
 or only trade or business carried on is the sale
 by retail of materials and supplies for or in
 connection with the carrying on by any person of
 a hobby or similar recreational pastime.
- 29. Hydraulic Equipment Shop
 "Hydraulic Equipment Shop" means a shop where
 the principal or only trade or business carried
 on is the sale by retail of hydraulic equipment.
- 29. Implement Shop
 "Implement Shop" means a shop where the principal or only trade or business carried on is the sale by retail of implements, including tools, power saws and parts, and air compressors and equipment.
- 30. <u>Jewellery Stores</u>
 "Jewellery Store" means a shop where the principal or only trade or business carried on is the sale by retail of jewellery, including watches and clocks.

- 31. Lawn Mower Shops
 "Lawn Mower Shop" means a shop where the principal or only trade or business carried on is the sale by retail of lawn mowers and associated equipment.
- Leather Goods Shop
 "Leather Goods Shop" means a shop where the
 principal or only trade or business carried on
 is the sale by retail of leather goods, and items
 manufactured from leather and leather substitutes.
- Marine Electronic Equipment Shop
 "Marine Electronic Equipment Shop" means
 a shop where the principal or only trade or
 business carried on is the sale by retail of
 Marine Electronic Equipment.
- Meat Shop "Meat Shop" means a shop where the principal or only trade or business carried on is the sale by retail of one or more of the following foods:
 - (i) Butcher meats;
 - (ii) Packaged Meats;
 - (iii) Dressed and Undressed Fowl;
 - (iv) Fish;
 - (v) Poultry.
- Motor Cycle Shops
 "Motor Cycle Shop" means a shop where the principal or only trade or business carried on is the sale by retail of motora cycles, including parts and equipment therefor.
- Nurseries
 "Nurseries" means a shop where the principal or only trade or business carried on is the sale by retail of trees, shrubs, flowers, bulbs and nursery stock.
- Office Supply Shop
 "Office Supply Shop" means a shop where the principal or only trade or business carried on is the sale by retail of office supplies including office machines, office furniture and office stationery and supplies.
- Pet and Garden Supplies Shop

 "Pet and Garden Supplies Shop" means a shop
 where the principal or only trade or business
 carried on is the sale by retail of animals or
 birds for domestic pets, and garden supplies.
- Photographers' Supply Shop
 "Photographers' Supply Shop" means a shop where
 the principal or only trade or business carried on
 is the sale by retail of photographic equipment,
 including cameras, films, picture frames and
 photographs.

- Picture Gallery and Art Supplies Shop
 "Picture Gallery and Art Supplies Shop" means a
 shop where the principal or only trade or business
 carried on is the sale by retail of paintings,
 prints, statuary, picture frames, art objects,
 and supplies for artists and craftsmen.
- 41. Record Shop
 "Record Shop" means a shop where the principal or
 only trade or business carried on is the sale by
 retail of records, tapes, and associated items.
- 42. Second Hand Shop

 "Second Hand Shop" means a shop where the principal or only trade or business carried on is the sale by retail of second hand or used goods.
- 43. Sewing Machine Shop
 "Sewing Machine Shop" means a shop where the principal or only trade or business carried on is the sale by retail of sewing machines, including parts and supplies therefor.
- 44. Shoe Store
 "Shoe Store" means a shop where the principal or only trade or business carried on is the sale by retail of shoes or footwear.
- 45. Sporting Goods Shop
 "Sporting Goods Shop" means a shop where the principal or only trade or business carried on is the sale by retail of goods and equipment for engaging in sports and recreational activities and including firearms and ammunition and bicycles.
- 46. Stationery Shop
 "Stationery Shop" means a shop where the principal or only trade or business carried on is the sale by retail of stationery for office or home.
- Tire and Battery Shoo
 "Tire and Battery Shop" means a shop where the principal or only trade or business carried on is the sale by retail of automobile tires and batteries or either of them.
- 48. Toy Shop
 "Toy Shop" means a shop where the principal or only trade or business carried on is the sale by retail of toys and games, or either of them.
- Variety Shop "Variety Shop" means a shop where the principal or only trade or business carried on is the sale by retail of sundry articles, including one or more of the following lines of goods:
 - (i) Notions;(ii) Statione
 - (ii) Stationery and school supplies;

(iii) Toys;
(iv) Dry goods and clothing;
(v) Pet and garden supplies;
(vi) 'Kitchenware, crockery and glassware;

50. Wool Shop "Wool Shop" means a shop where the principal or only trade or business carried on is the sale by retail of wool, needles, patterns and associated items.
