

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 6378

A By-law to exempt from taxation certain lands and premises within the Municipality pursuant to Section 328 (1) (c) of the Municipal Act

The Council of The Corporation of the District of Burnaby  
ENACTS as follows:

1. This By-law may be cited as "BURNABY TAXATION EXEMPTION BY-LAW NO. 8, 1973".

2. The following lands, and the improvements thereon, are hereby exempt from taxation imposed under clauses (a), (c), and (c) of subsection (1) of Section 206 of the Municipal Act for the year 1974, namely:

(a) Those lands occupied and held by the Children's Foundation and being described as Lots 14 and 15, Block 32, of District Lot 186, Group 1, Plan 1124, New Westminster District, shown outlined in Green colour on the sketch annexed by By-law No. 4848 and marked with the letter "A".

(b) Those lands occupied and held by the Elizabeth Fry Society of British Columbia and being described as:

(i) Lot 8, Block 17, District Lot 186, Group 1, Plan 1124, New Westminster District, shown outlined in Green Colour on the plan annexed by By-law 5445 and marked with the letter "A".

(ii) Lot 10, Block 8, District Lot 116 and 186, Group 1, Plan 1236, New Westminster District, shown outlined in Green colour on the plan annexed to By-law 5445 and marked with the letter "B".

(c) Those lands occupied and held by the Action Line Children's Village Society New Family Home, and being described as Lots 11 and 12, Block 56, District Lot 98, Group 1, Plan 2066, New Westminster District, shown outlined in Green colour on the sketch annexed to By-law No. 5589 and marked with the letter "D".

(d) Those lands occupied and held by the Action Line Children's Village Society New Family Home, and being described as Lots 4, 5, North Half and 5 South Half, District Lot 35, West 5 acres of 10 acre part, Plan 2301, Group 1, New Westminster District, shown outlined in Green colour on the sketch annexed to By-law No. 5585 and marked with the letter "F".

(e) Those lands occupied and held by the Elizabeth Fry Society of British Columbia and being described as Lot 21, Block 8, District Lot 99, Group 1, Plan 10988, New Westminster District, shown outlined in Green colour on the sketch attached to By-law 5984, and marked with the letter "A".

(f) Those lands occupied and held by the Action Line Children's Village Society New Family Home, and being described as the Westerly 165 feet of Lot 134 of District Lot 92, Plan 1146, Group 1, New Westminster District, shown outlined in Green colour on the Sketch attached by By-law #5983 and marked with the letter "B".

(g) Those lands occupied and held by the South Burnaby Golden Age Society and being described as North Half of Lot 7, sub-divisions 35/36, Block 1, District Lot 158 the North West Quarter of the North half of the South West Quarter, Plan 1940, Group 1, New Westminster District, shown outlined in Green colour on the sketch annexed to By-law #5982, filed in the Land Registry Office at New Westminster, and marked with the letter "C".

(h) Those lands occupied and held by the Lower Mainland St. Leonards Society and being described as Parcel "E", Explanatory Plan 17224, R.S.D. 8, 9 and 10, Subdivision 1, Block 16 of District Lot 79, Group 1, New Westminster District, shown on sketch attached to By-law #5980 and marked with the letter "E".

(i) Those lands owned by the United Church of Canada, (and occupied by the United Church Girls Home and a Retarded Children's Home) and described as follows:

COMMENCING at the North East corner of Lot "B" of the South East Quarter of District Lot 149, except Sketch 11860, Plan 3160, Group 1, New Westminster District, thence West following the North boundary a distance of 233.62 feet, thence South along boundary a distance of 430.7 feet, thence in an easterly direction for 233.62 feet to the east boundary, thence North and parallel to Sussex Street a distance of 430.2 feet to point of commencement, shown outlined in Green colour on Sketch annexed to By-law #5981 and filed in the Land Registry Office at New Westminster, and marked with the letter "D".
