AND WHEREAS the said portion of road is no longer required for road purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

- This By-Law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 10, 1973".
- 2. That portion of road being all and singular those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being a portion of District One hundred and thirty five (135), Group One (1), Plan 16513, New Westminster District, which said portion is more particularly described as that portion of road in District Lot One hundred and thirty five (135), Group One (1), New Westminster district, dedicated as road by Plan 16513 and as shown outlined in red on By-Law Plan prepared by G.E. McLaren, B.C.L.S. and dated the second day of October, 1973, a copy of which is attached hereto, is hereby stopped up and closed to traffic.

The Mayor and Clerk are hereby authorized and empowered to petition the Lieutenant-Governor in Council to abandon the said portions and vest title thereto in the name of The Corporation of the District of Burnaby.


