

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW 6412

A BY-LAW to amend By-Law No. 3089, being the  
"BURNABY TRADES LICENCE BY-LAW 1950"

The Council of The Corporation of the District of Burnaby  
ENACTS as follows:

1. This By-Law may be cited as "BURNABY TRADES LICENCE BY-LAW 1950, AMENDMENT BY-LAW NO. 1, 1973".
2. Part I of Schedule "A" of By-Law No. 3089, as amended by By-Law No. 5733, is repealed and the following substituted therefore:

"SCHEDULE "A"

PART I

Every person carrying on, maintaining, owning, or operating within the Municipality any profession, business, trade, occupation, calling, undertaking or thing enumerated hereunder shall pay to The Corporation of the District of Burnaby the amount of the annual license fee set opposite to the profession, business, trade, occupation, calling, undertaking or thing carried on, maintained, owned or operated by such person.

| 6. Music or Elocution Teacher operating from a home  | 20.00   |
| 7. Dance Instructor operating from a home  | 20.00   |
| 8. Private School and Kindergarten   | 40.00   |
| 9. Trailer Camp (whether operated with an existing Auto Court or not)  | 50.00   |

3. Part II of the said Schedule "A" is repealed and the following substituted therefore:

"SCHEDULE "A"

PART II

Every person carrying on, maintaining, owning, or operating within the Municipality any profession, business, trade, occupation, calling, undertaking or thing not hereinbefore enumerated shall pay to The Corporation of the District of Burnaby the annual license fee as follows:
